Family Day '85

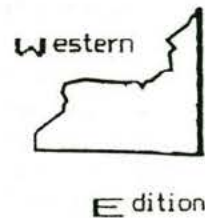

World's most sensational model is a man!

The sexiest woman in Brazil is a man!

She's stunning Roberta Close, a curvaceous model whose sensuous beauty men find irresistible — even though they know she's the wrong sex.

The 5-foot-10 raven-haired transvestite is a magazine cover girl and has even been in Playboy magazine. And although the whole world knows she's not the gorgeous girl she appears to be, no one seems to care.

"She's the talk of Brazil," magazine writer Regina Rito told The NEWS. "She's not an actress, she doesn't sing, she's just a boy being a girl."

"In terms of her effect on people, the only comparison I can make is Marilyn Monroe, transformed from a timid blonde into a fantasy woman," gushed an editor of Brazil's Playboy, Ivo Cardozo. "As far as I'm concerned, she's earthshaking."

Roberta, 22, was born one of four sons of a middle-class family in Rio de Janeiro. She was christened Luiz Roberto Gambine Moreira, but although she appeared normally male she says she never felt like a boy.

"Ever since I knew I was human, I knew I was a female," she said. "The old story about 'boys' who love to play with dolls, who enjoy playing house, who hate violent sports — that happened with me, too."

When she was 16, Roberta's parents were so concerned about their son's femininity that they took their child to a doctor. Tests showed that Roberta was suffering from a lack of male hormones, but, although the disorder could easily be treated with hormone shots, Roberta refused them. "Clinically, it would have been easy to begin treatments to give me a beard, a deep voice and all those things," she said.

"But I absolutely didn't want to change.

"I always felt that I was a girl and I wanted to have female hormones to preserve my

real nature. I was sure that I'd never be a macho male — with or without treatment."

At the age of 17, Roberta was photographed at the beach by an Argentinean magazine and her rise to fame began. Since then, she's won beauty competitions, appeared in magazines and newspapers, and made television commercials. Famous singers write songs about her, people pay her to show up at their parties — and she's been offered work as a top model in Paris.

"The job market for transvestites and transsexuals is extremely complicated," she said. "I'm an exception. Everything has been much easier from the moment I became famous.

"Now everybody wants Roberta Close, everybody wants to invest in me.

"Actually, this pace scares me a little bit. Really, I was

ROGER'S NOTEBOOK

One of the problems faced by all cross-dressers is who to tell about their needs. The next problem is when and how to make this disclosure. It seems to me that it is neither desirable nor necessary for most cross-dressers to come completely out of the closet. However, opening the door and letting in some light is necessary for support. Telling someone about your cross-dressing is scary and risky, for there is always the chance that the relationship will be irretrievably damaged by your disclosure. There is no simple or right way to go about telling someone but there are some guidelines that can be helpful.

First, how to decide who to tell.... A good rule of thumb is that it is necessary to confide in persons who can be effected by your needs. This can be a wife or girl-friend or perhaps some close relatives or friends. A guiding principle in making the decision is whether a particular relationship is being influenced by your need to hide your cross-dressing. For example, if you become moody and withdrawn because you can not dress when you feel the need and you can not explain this to someone in an intimate relationship with you, that can be an indication that you should confide in her.

When to make this revelation.... It is usually advisable to do this as early in the relationship as seems possible. For some relationships this might be in the first month and for others it might be in the first year. The longer that you wait before divulging the information, the more the other person can feel deceived when they find out. This feeling of deceit can cause them to react with anger and rejection. Further, they may feel they can no longer trust you. The exact timing is up to you. I have found from my study that once both people are committed to the relationship it is nearly too late to easily make the 'confession'. This is especially true if the relationship is leading toward marriage. Since the only 'cure' for cross-dressing is acceptance and working out appropriate times for its expression, going into a long-term intimate relationship without working out these details can lead to significant problems later. Telling your own children is a very special situation and should most probably be delayed until they are in their teens or later. There are no studies that show the effects of telling young children but this information adds to the many other things they have to deal with as they mature.

How to gently provide this information to the other person is probably the most difficult part. You -- the cross-dresser -- will most probably be very nervous and on the defensive. Just think how the other person must feel. She (or he) most probably knew something was wrong but most probably had no idea what it was. Then too, she probably has very little understanding of cross-dressing and may confuse it with either transsexualism or homosexuality or both. YOU have to be sensitive to HER needs. Do not try to bury her with information but answer her questions truthfully and simply. Make the disclosure in stages, for the worst thing you can do is to overwhelm her. Sometimes pictures are a good place to begin. Be very sensitive about letting her see you cross-dressed for the first time -- which MUST be done gently and preferably in a private situation. While the first time may be the hardest, she will have to see you cross-dressed several times in private before either of you will know what her reactions and feelings really are.

If you follow all the above guidelines you have a chance that the other person will at least be tolerant of your cross-dressing. Keep in mind that even if you do all of the above, she may not want to see you dressed or participate in any of the activities that involve cross-dressing. Here is where you must be sensitive to her and not press for acceptance or participation.

EARLY MEMORIES

Dear Edith Marie,

Your article in the January (1984) issue of "Our Special Joy" on your earliest recollections of cross-dressing prompted me to write to you, after much deliberation, to tell you of my earliest memories of how I became aware of the woman within me. I would like to share my story with the other Chapter members.

First of all, I would like to say that I am very happy I am a trans-vestite. I am happy to be able to have "Joanne" released so that she may enjoy the femininity she is entitled to. I truly believe she is a woman, having been born one.

I was a Depression baby. I had three sisters older than me and one brother four years my junior. Dad, like most fathers during those troubled times, toiled twelve or thirteen hours a day to keep a roof over our heads and food on the table. The Depression was a terribly worrisome period for our parents, but for us children, we had wonderful times playing and growing up together. Memories of those early days are mostly pleasant ones for me.

I know Dad did not neglect us, but he worked such long hours, we children got to see him only on weekends. The weekends were special. They were reserved for family fun activities. We would visit with relatives, go on picnics, church outings, hikes in the country and occasionally attend a movie matinee. They were low-budget amusements, but we all enjoyed them very much.

I don't think Dad spent any more or less time with me than the typical hard-working Depression-era father. Of course, my time with Dad had to be shared with my brother and sisters. With Dad away from home so much, most of my waking hours were spent in the company of females - my mother and three older sisters - up until the time I entered Kindergarten. I guess there were other boys in the neigh-

borhood, but I really don't recall playing ball or tag or any other of the rough and tumble outdoor games so popular among the boys. During those pre-school years I loved to play house with the youngest of my sisters, who was only fourteen months older than me. I remember having so much fun playing with dolls, dressing them in their frilly little panties and slips and fancy, colorful party dresses. Mother gave us some cast-off clothing to play with and my sister and I had a great time pretending we were grown-ups. Sometimes I would play the role of the mother in our little make-believe family. At other times my sister would be the mother and I would be the visiting Aunt Sadie. It seemed perfectly natural to me to play a female role. At times I would wear my sister's dresses or skirts and we would play outside. Mother knew about this, but never stopped me or made any kind of fuss over it. So, before I entered school, I was quite accustomed to wearing girl's clothes.



When I was about five years of age a strange incident happened that will forever be firmly imprinted in my memory. One of my little girlfriends in the neighborhood made her Holy Communion. Her mother made her a beautiful white, lacy dress and veil for the occasion. I remember going over to her house and seeing her BROTHER wearing her dress and veil. I was not the least bit shocked by this because I thought that other boys had the same kind of play experiences at home that I was so used to. I, too, wanted to try the dress on and my little girlfriend helped me into it.

That was my earliest recollection of crossdressing away from home. I often wonder how her brother turned out. Up until the time I made my First Communion, I really thought that I would wear a pretty white dress on that special day. I had no idea of the bitter disappointment that lay ahead.

I enjoyed going shopping with my mother and sisters, especially when we went clothes shopping. I had household chores to do, the same as my sisters. We took turns washing and drying the dishes and helping with the laundry and the dusting. We learned to crochet, sew and iron, so to me this was all quite normal. "Joanne" was truly out in the open in those early days.

I entered Kindergarten when I was six and wore dresses around the house and in our backyard up until that day. Nobody forced me into it. It was something that I wanted to do and enjoyed doing and, as I said, Mom never made any fuss over it. Dad was probably not aware of my fondness for girl's clothes because on weekends I wore boy's clothes for our family outings. When I started school, Mom took a firm hand, though, and made me go to school in boy's clothes. I didn't care for that at all. As soon as I would get home from school, I would change into a dress. I did this for about six months, then got too lazy to change when I got home.

I was never the typical example of what a boy "should be". I did not care for sports or for any kind of roughneck activity. By the time I made my First Communion, at age seven, I was resigned to the fact that little boys just did not wear dresses. I had to suppress my desires for girl's clothes and direct my energies toward masculine activities. I became an altar boy and a Boy Scout and tried to go the way society demanded.

I attended parochial elementary and grammar schools. The codes of conduct and dress were very strict and the nuns ruled with a firm hand. One time, in grammar school, I was reprimanded for talking when I should have been listening. The good Sister told me that, if I continued talking out of turn, she would have one of the girls in the class bring in a spare dress and I would have to wear it. This

caused some amusement among my classmates, but I thought, "Oh, if you only knew. I could bring in my own dress." Sister thought the "petticoat punishment", as I learned it was called many years afterward, would embarrass me into compliance with the classroom rules. I wonder what her reaction would have been if she knew that I would have much preferred to wear dresses than boy's clothes? Yes, it was funny and I chuckle now when I recall the incident, but it was also supremely ironic.

When I was fourteen I got my first taste of wearing grown-up girl's clothes - girdle, bra, nylon stockings, high heels, makeup, the works. I was home alone at the time and I was admiring myself in the full-length mirror in my oldest sister's bedroom when she came home from work sooner than expected. As I heard the front door open and shut and then her footsteps on the stairs, a sick, sinking feeling hit me in the pit of my stomach and my knees felt like rubber. I could not escape. I stood there, frozen in panic, as she opened the door to her bedroom. But, that's another story for some other time.

But, did you know that the famous child actor of the twenties, Jackie Coogan, played a poor, unwanted lad in A Boy Of Flanders (1924), who dresses up as a girl to attend his girlfriend's party? His disguise is discovered when he gets sick from eating too many chocolate cakes.

In the 1974 movie Thunderbolt And Lightfoot, Jeff Bridges plays a young drifter who teams up with veteran thief Clint Eastwood to pull an armory heist. The intricate plot involves Bridges masquerading as a young chick to lure an over-zealous employee from his vital post. His excellent portrayal won him a supporting actor Academy Award nomination.

These and many more examples can be found in What A Drag! Men As Women And Women As Men In The Movies, a recent addition to the Chi Delta Mu Library. In 265 pages and more than 400 black and white photographs author Homer Dickens explores this fascinating subject. Thank you, Lora, for donating this excellent book.

We now have 58 books, four audio tapes and one video tape in the "serious" section of our Library. The fiction & fantasy section has 64 items. The privilege of borrowing from the Library is available to members and their spouses and the only cost is fourth class return postage.

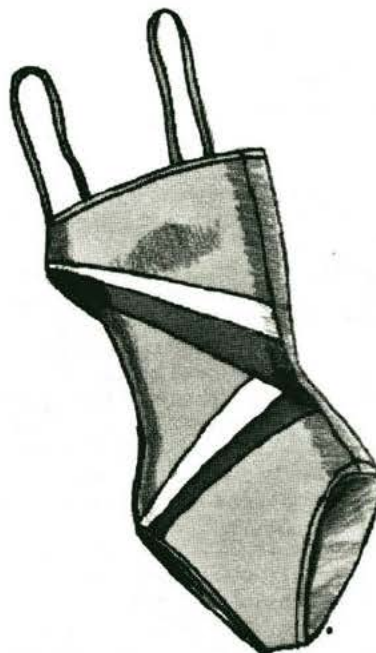

Editorial

The next obvious question then is, why have a National Organization? Aside from the fact that had there been no National Organization there would be no CHI DELTA MU Chapter, having a National Organization has many important advantages. Sometimes these advantages are not so obvious. A National (really International) TRI-ESS Organization provides among other things!

- the necessary machinery for a broad-based recruitment and publicity effort supporting the position of the male, heterosexual crossdresser;
- the framework within which the chapters of the Organization are established, develop and operate;
- a safety net for sisters and loved-ones buried very deeply under society's rock of norms and customs.

Perhaps the best rationale for the National Organization is summed up in the saying, "There is strength in numbers".

The financial statement published in the latest FEMME MIRROR indicates that over 3/4 of the National's expenses last year were for printing and postage. That's printed material sent to you in the mail as a member of the National Organization. The quantity may not be what we desired, nor what was promised, but it is better than nothing. When consideration is given to what is behind publications like the FEMME MIRROR, namely a National Organization and all that that entails, then the need for the National Organization should become that more obvious to those who are its beneficiaries -- we who are its members.

So, I'm renewing my National dues this month. I think it is a wise investment in my future. I hope that you agree and will also renew your dues or finally join us in total sisterhood for a better future for us all.
