FROM THE EDITOR...

On The Road Again



Well we made it; left SF early on Wednesday, June 2 - although it took forever for us to get out of California (top speed limit for towed trailers: 55mph), what with adjusting the tarps a couple of times and one amusing incident on I-5 - we had just made

a pit-stop, gotten something to drink, tightened the ropes a bit more, cranked up a tape on the stereo and were toodling along nicely when all of a sudden the engine conked out. We were already concerned about the truck's capacity to tow the extremely heavy load we had packed (almost burned out the clutch on the hills of SF), so when we were forced to the side of the highway in the middle of nowhere all sorts of terrors formulated in our minds. Micheal immediately popped the hood and began poking around (as the expert mechanic he is) when all of a sudden some lightbulb went on in his head and he called to me, "what does the trip odometer read?" I replied with a figure around 300 miles and with that he closed the hood, wiped his hands and said, "I know what the problem is." "Serious?" I queried. "We're out of gas," came the answer.

Seems he neglected to tell me that the fuel gauge was broken (perpetually fixed at 3/4's full) and that he refills the tank based on the miles traveled since the last fillup. With all that was on our minds he'd forgotten to check the odometer at that last stop, so in penance he started walking down the interstate and I settled in with my novel when a passing trucker with a cellphone let him call 911 and the CHP dispatched a towtruck for us. One hour later, \$65 for the service call, \$10 for five gallons of fuel and a \$5 tip, we were headed for the first gas station we could find - talk about the price of gasoline! Sheesh! Needless to say, I haven't been letting him off the hook on that one!

But we got a giggle out of it and made it as far as Kingman, AZ (thirteen hours after we left SF) before we decided enough was enough and crashed for the night. The next morning we resumed our eastward journey and drove straight through all the way to Oklahoma City (once out of CA, the speed limits went up to 70mph, towed trailers notwithstanding), covering all of Arizona, New Mexico and the Texas panhandle, arriving in OKC around 2:30am (local) on that following Friday. Needless to say, we were exhausted but joyous at arriving safely and in record time.

First Impressions

So I've been here about two weeks now. My first impressions of Oklahoma City? Pink Cadillacs on historic Route 66 (passin' through about a mile from our house), strip mall mania, cowboy hats, way too much religious programming on cable, pawn shops on every corner, pickup trucks rule (gun racks and hound dogs optional), fireworks stands, and there are no friggin' sidewalks anywhere! I have to drive wherever I want to go (even if it's just a few blocks away). Pedestrian traffic is an oddity and is cause for overt stares from passersby. Public transportation? Hah! The locals speak with real pride in their voices that their buses run "every hour on the hour." (*groan*) Having grown accustomed to hoofin' it around SF via MUNI and my own two feet, it is noticeably depressing. You people out there have no idea how good you have it. The roads themselves here leave much to be desired, and a lot

PRESIDENT'S MESSAGE

Several years ago I was back in Manhattan for a few days visiting a friend and walking all over the lower half of the island. Saturday night we happened by Stonewall which is where the LGBT movement really came out of the closet and I remember thinking that it looked like a quiet, fun and very "normal" looking place. There was nothing to draw undue attention to itself. The significance of course is that just thirty years ago this month the police once again raided the place and the patrons decided that enough was enough and fought back.

This month Pride celebrations will take place all across the country and many people will march to affirm their commitment to be themselves. Actually I think it is better to say that they will affirm that they do not have any real viable alternative other than to be themselves and that they are happy to be what God and life have created in them. Also many people (in S.F. it is estimated between 300,000 and 500,000) will line the streets to watch and affirm their support for human rights for all people and to shout their friendship and support for the LGBT community.

To be sure some will stand back and disapprove and some will read their Monday newspaper and muse about what the hell is going on. Some will want to blame the Y2K problem on us or ponder what form God's judgment will take (as if they are closely connected).

Then I will think of the good people at the PFLAG meetings that I have been privileged to attend and our talented friends in the gay and lesbian communities and I will smile. I will think of all the interested and supportive people in the community at large and the participants at many of our outreach presentations and I will smile. We are making inroads. I will think of my neighbors who converse with Leslie as well as Steve. I will think of Dick Giles who successfully taught her final year as Diane. Mostly I will think of all of you and the huge role that you have played in the emergence of a confident Leslie.

By the time that you read this we will have already marched in the parade. Let me thank now all those who participate and all those who will have worked hard to make it happen.

I'm glad that this event is called a "Pride Celebration" and not just an LGBT parade.

of the freeway interchanges seem to have been designed by pretzel logic with a mobius strip thrown in for good measure.

But we only pay \$425 for our 2-bedroom house (our yards are huge! I actually got out and mowed the lawn the other day - first time I've done that in over twenty years!), unleaded gas is only 93¢ a gallon and I can buy my favorite vice for 75% less than it cost me out there. And the best part of it all is that I get to curl up next to my baby every night and my heart sighs with contentment, knowing that everything's going to be alright.

Still looking for meaningful work. Yes I've done all my shopping at Wal-Mart. Found a very good nail salon and a decent little independent lingerie boutique. The weather here is marvelous - hot, sunny and muggy one day, dramatic dark gushing thunderstorms and lightning the next. Even when it rains (at least this time of year) it's still 78° and the wind is warm. Compared to SF, with its biting cold wind off the bay, I find it infinitely more endurable.

TG Life In The Mid-West

More first impressions: the TG community here is much smaller of course, loosely organized around a group called C.O.T.A. (Central Oklahoma Transgender Alliance), and a monthly newsletter called *The Southern Belle*. COTA is comprised of three S.I.G.s (Sister Interest Groups), each with a particular focus - *Sigma Beta*, a support group primarily for hetero crossdressers, their partners and families; *Sooner Diversity*, an open support group for all TG persons, orientation and gender, and is also a Renaissance affiliate; and finally *OK New Men & Women*, a support group focusing on the needs of M2F and F2M transsexuals, and is an AEGIS affiliate. I intend to sign up and dive in, see what assistance I may provide and generally make myself useful if not supportive.

The surprisingly thriving GLBT community here is gearing up for their pride celebration. Tulsa upstate is having their first one ever, which might be interesting to attend - a little in-your-face activism would be invigorating if not downright necessary as the conservatives up that way intend to counter-demonstrate. Rep. Barney Frank himself is one of the headliners in Tulsa, and I'm tempted to go just to get in HIS face!

There's a small area of OKC that acts much like SF's Castro district and all the flags are flying this week, large and proud. Warms the cockles of my little heart. Micheal and I will be marching in the parade, not with the TG group however, but with PEP-OK (People Exchanging Power Oklahoma) as our mutual interests lay more with the leather crowd. I find it reassuring that there is a sizable number of interesting and friendly perverts here and Micheal and I are fitting in quite nicely <insert very evil grin here>. I'm probably the only TS (that I'm aware of at this early stage) who's a member of PEP-OK, so I'm also going to carry a sign that states "Transgendered And Loving It!" (gee I wonder where that came from?). While ya'll are traipsing down Market Street in the biggest bestest pride celebration in the whole country, I'll be doing my small part in this sleepy little burg.

I miss my friends. I miss the beach. I miss the fascinating architecture. I miss MUNI. I'll miss the Folsom and Castro Street Fairs... *sigh* Further adventures of my Green Acres saga ("goodbye city life!") will be continued in the August issue.

ExCOM MEETING MINUTES

The monthly meeting of TGSF's Executive Committee was held in Sebastopol on June 6, 1999, at 3:00 p.m. In attendance were President Bailey, Vice President Blau, Secretary Camino, Treasurer Ryan, Outreach Co-Chair Adams, Social Co-Chairs Cook and Cook. Also present were guests Deborah, Susan, and Rachael. Not attending because of illness was Outreach Co-Chair Sparks. Education Co-Chair Cupps was returning from a Conference in Cleveland and Education Co-Chair Marie was attending to personal business. The meeting was called to order at 3:36 p.m.



Communications and Announcements: President Bailey announced that the Aids Walk is Sunday, July 18, 1999 and asked who would be in charge of it for the organization. Janis reported that the Esprit Conference in Port Angeles, Wash. was very good and that she attended with Karen Andrews. Leslie mentioned that KQED Pledge night for TGSF was set for June 20, the Closet Ball is June 12 and that the date for Cotillion 2000 is now January 29. Because of remodel work at the Design Center, the date was moved back from February 5, 2000. It was also noted that "past due dues renewal notices" were sent by mistake to all TGSF members and that it has generated a lot of mail of concern.

Old Business: Janis asked about a bill still outstanding from the Cotillion. The books need to be closed. Leslie will look into the matter.

Minutes: With no corrections from the ExCom, Debbie moved for May's Minutes to be approved, Lulu seconded the motion and they were unanimously approved.

President: Noting that what was to be reported was all work of the Vice President, Leslie gave over the President's report time to Vice President Blau.

Vice President: Lulu is trying to hold a Cotillion meeting in June but it is a busy month with the Pride Parade and Big Shew included. The first rehearsal for the Big Shew was held Saturday. The next rehearsal is scheduled for Saturday, June 16. Nicole asked what is needed to plan the Big Shew and what goes on at the rehearsal. Lulu stated the Big Shew is arranged into a show with a theme and "flow" and that all participants and acts must work with a show performance in mind besides individual acts. They will perform as a group also. Janis asked about fees charged by Kimo's for the Big Shew. Debbie said there is a bar guarantee and no room fee. Janis asked about other costs. Leslie said there are some minor reimbursements for decorations, equipment rental and sound person: P. Kelley. Janis asked if Big Shew costs could be invoiced. Lulu said the show is usually on cash paid basis, once the show is over. Janis said these things should usually be done on an account basis. Telzey mentioned that the Big Shew should be advertised soon in local gender and lifestyle magazines. Leslie completed and Lulu issued the press release for the Big Shew to the ExCom. Lulu said there is also a rehearsal June 19, at 2:00 p.m. Lulu mentioned there has been less time to advertise and plan the show because of its closeness to the Pride Parade. Deborah asked about a raffle at the Big Shew, mentioned in the ExCom Manual. Lulu said that is the responsibility of the Social Chair or Co-Chairs as is the whole show. However, Lulu is producer because of her expertise from doing show many times before.

Lulu mentioned there is a parade meeting next Saturday at 2:00 p.m. A rough float design now exists and a title: The New TG Face." The theme will be makeup oriented. Leslie said she needs \$100.00 for a rental of a float assembly place. Lulu men-

tioned that candy had been given out at past parades. This year it will be makeup samples and she is asking for donations of more. Lulu said she needs about twelve volunteers as monitors - a requirement of parade participants. Leslie asked about signs and the banner. Nicole said she is revising them.

Secretary: Secretary Camino mentioned that there were items requested to be new business by Janis, Roxanne, Nicole and Debbie, the major items being the newsletter, the move of the Editor and need for contingent plans. Leslie made the issue of the newsletter an action item that should be discussed at this time in the ExCom meeting and the discussion was brought up. In regards to the newsletter mailing - pick-up, folding, stamping, labels, Debbie offered to handle this process. Leslie said for Debbie to go ahead but she will trade off with her and also look for other volunteers. In regards to newsletter processing, the ExCom reviewed the current status of processing. Deborah said that Ayme needs to have material sent to her, electronically or by any means to meet deadline. Ayme will post and assemble newsletter and send it to the publisher at the usual time. Janis said she will work with Ayme on the advertising accounts and that she will also have help with this. Leslie wants to see the trend of newsletter output, content and income to continue. Because of limitations on the Secretary due to workload and the need for a contingency editor, it was agreed that an Associate Editor is needed to handle loose ends and local issues or problems, which may develop. Leslie said she would think of and look for persons that could be an Associate Editor.

In returning to the Secretary's report, Roxanne mentioned she had participated in an outreach activity with Sandra, at the College of Notre Dame. Roxanne mentioned the numerous difficulties she is having with the tgforum E-Mail and cannot use it for posting minutes. She had contacted the administrators of tgforum for help. Janis will try to help with the situation.

Treasurer: Treasurer Ryan has posted the current figures. As of the May 27 Social Meeting, there were 151 current members. 150 members from the previous year had not yet renewed, and there was one new member. Janis has signed the organization up for on-line banking. Janis also mentioned that committees such as education and outreach are breaking even on expenses. Janis is also developing a policy on memberships with returned checks.

Education: In the absence of the Education Co-Chairs, there was no report. The Education Seminar was not scheduled because of difficulties Tianna was having getting possible speakers or participants to return her phone calls and not by lack of effort by the Education Co-Chairs.

Outreach: Outreach Co Chair Adams noted that Sandra had sent in honorarium and a final list of outreach sessions done under tenure. Telzey asked about food at the Pride Parade for group participants. Is it provided and by who? Leslie said the parades in the past had food but not the last year. Telzey said she would bring some food for the TGSF volunteers. Telzey knows of three people who will take pictures at the parade and that digital photos will go to Ayme. Telzey would like more volunteers for the TGSF booth and is looking for a booth banner. Telzey mentioned that Theresa is redoing all the TGSF outreach brochures. The KQED Pledge Night for TGSF participation is Sunday, June 20, 1999. The full Pledge Night runs 6:00 p.m. to 11:00 p.m. and it is John Denver Concert night. Lulu asked if Telzey and Theresa would continue Speakers Bureau. Telzey said Theresa would continue to handle it.

Social: Social Co-Chair Debbie Cook handed out to the ExCom instructions on how to import items to the TGSF Calendar on the website. Social Co-Chair Nicole Cook said with the proper URL, the Treasurers report will be linked to the TGSF website.

Debbie said other ExCom Committees would soon have their own link. The June End-Of-Month Social is at Kimo's on the 24th and it is the "Really Big Shew." The June Mid-Month Social is at Cafe Mars on the 9th. The Mid-Month Social for July may be a return to Josie's. Janis will look into the Pyramid Brewery in Berkeley as a possible social location. Roxanne mentioned service at the Blue Muse for the May EOM Social greatly improved. Debbie mentioned that because of the large number of people attending the social for election purposes, the Blue Muse staff was having a hard time keeping up with all the orders. Everything should go back to normal now that elections are over. The ExCom moved to the Cook's computer room to view and vote on a membership card design. By unanimous vote, a design featuring the Golden Gate Bridge was selected. It is the same as pictured on the website home page. As an option, a member photograph can be included. ExCom members also viewed updates to the TGSF website.

New Business: Because of the length of the ExCom meeting, items of new business were brought up, but to be acted upon, after research, at the next or future meetings.

1. **Publications:** Janis requested that all methods of publications of TGSF, be consistent and up to date and that everyone involved in publications from the group knows what the other is doing.
2. **Confidentiality:** Janis expressed concern of confidentiality of members in print, photo and electronic means. A policy must be in place and concerns addressed. Janis and Roxanne both mentioned recent instances of member names published that should not have, including newsletter, website and birthday references. Janis said there should be a clear policy of what will go into the website and that all policies concerning confidentiality are in place and followed. Leslie said that pictures of unrecognizable or non-regular members should have a permission release. Janis also mentioned a policy of picture use should be in place. Janis will come up with a photo release form.
3. **Website Links:** Janis stated that some advertisers and some fellow transgender groups have outdated links to TGSF and they should update them. Debbie mentioned that she had contacted Carla's webmistress and asked them to update the outdated information, but because the webmistress' computer has been down, the updates have not been put into effect yet. Janis said the ExCom officers should each have a tgforum address.
4. **Corporate Identity:** Janis mentioned that the group needs to update non-profit corporation papers to TGSF and

not ETVC doing business as TGSF. Leslie will look into the issue with Sandra.

5. Nicole brought up the discussion of all TGSF communications and publications methods being put into a committee, but that each communication method should have its own controlling person who has responsibility.

Next ExCom Meeting: July 11, 1999, in Albany, Calif., at 3:00 p.m.

At approximately 6:28 p.m., Nicole moved to adjourn the meeting; Janis seconded and the motion was unanimously passed.

SPECIAL NOTE: To those who have contacted me about your membership status because of the notice included with your newsletter, I appreciate your concern. Because of the amount of mail that was generated, I cannot respond to each of you individually.

The "late dues" notices were only to go to those members who have not renewed. The newsletter party, being a hard-working group, saw the notice as a flyer, realized there was not enough for every newsletter, copied more and included them to everyone. The ExCom is sorry for the confusion this may have caused.

Mailing Miscues

First of all, let me apologize to those of you who had already renewed your membership but received the yellow insert with the June Newsletter stating:

Member Renewal Notice

This is your LAST issue

Renew now to ensure delivery of The Channel

Since at the time of mailing the newsletter, over half of the members during the 1998-1999 year hadn't renewed their memberships, the new ExCom decided to send newsletters to both those who had renewed, and to include the notice only in the envelopes sent to those members who hadn't yet renewed.

To facilitate this, I printed mailing labels in the following format:

Here, 2040 is my membership number, and the 99 meant that I had renewed my membership for the 1999-2000 membership year. So, the pesky yellow notices were supposed to go only to those with a "98" on the label.

Unfortunately, that instruction wasn't made clear to the person who actually stuffed the envelopes, and she stuffed them into everyone's newsletters! I was surprised when I got one myself! And, as expected, I and other ExCom members received a lot of communications, some understanding, some angry, from other people who like me had already renewed their memberships. I spent some time that evening replying to email messages and verifying that our records showed that we had received their renewals, and to others telling them that, though things were delayed since I had been out of town at Esprit, I had finally received their checks and deposited them.

What's in a Name?

Another word about names, birth dates, and the other information that is requested on the membership renewal forms. First of all, in accordance with our bylaws (which you can view in full on the Internet at: <http://members.tgforum.com/janisr/tgsf/bylaws.htm>):

X. CONFIDENTIALITY.

The Membership and Mailing lists are confidential. Access is limited to official ETVC use; no member may make a copy of any portion of the list; members may request special mailing instructions to insure confidentiality; and the membership and mailing lists shall not be sold or transferred to any organization for any purpose whatever.

The "Preferred Name" that you enter on the membership form will be used in all references to you by the organization, such as in the "New Members" and "Birthdays" section of this newsletter. I'm "Janis Ryan" there. The "Mailing Name" and address that you specify will be used for sending newsletters and other mailings from the group, unless you request some other method of delivery. There, I use the name and address that my letter carrier has become familiar with over the years!

Also, we only request the month and day of your birth, and only use it to include your Preferred Name in the monthly Birthday list in the newsletter. Finally, if you provide us with an Email address, it also will be used only for individual messages from me or another member of the ExCom. I don't believe in spamming!

One of our members created a TGSF Email list which you may wish to join, by following the instructions at: <http://www.egroups.com/group/tgsf/>. Once you are registered, you will get all of the messages sent by yourself and others to tgsf@egroups.com. I have used it in the past, such as when I started getting personal Email messages about the renewal notice, and I and other ExCom members will use it to pass on late-breaking information on our events. We will also post them in the Calendar section of our web site at: www.tgsf.org. Note that this list is unmoderated, and is not an official publication of our group.

TGSF? ETVC? What's Happening?

Last year our membership voted to change our group's name from ETVC, or Educational TV Channel, to TGSF, or TransGender San Francisco. What has happened so far is that we have filed a "Fictitious Name Statement" with the City and County of San Francisco, and that we are now legally "Educational TV Channel" doing business as "TGSF." Within the next months, I will be working with the ExCom to formally change our Bylaws and Articles of Incorporation to reflect our new name.

TGSF OUTREACH

Outreach is an interesting function as it relates to TGSF and the transgender community at large. It encompasses many different activities and involves a great number of very special individuals...far too many to mention in this article. Besides, even if I tried to list the names of the many people who have contributed to the Outreach efforts of TGSF and the transgender community, I would never be able to do so.

One of the primary functions of Outreach has been, and continues to be, the Speakers Bureau. It is comprised of people who volunteer to speak on behalf of TGSF and give of their time and of themselves to educate society on the transgender phenomenon and to help demystify the terms crossdresser, transvestite, transsexual, FTM, MTF, drag queen and all the other labels placed upon all of us. They bravely go out, in many cases alone, to show others we are not strange or weird or perverted or sick but that we are everyday human beings with a name, a face and a life. They personify the values of the organization and bravely demonstrate that we are, in fact, a cross-section of American society. We are the rich, the poor and everything in between. We represent the homeless and the landlord, the educated and the experienced, not to mention the young and the old. Our Community is a diverse one, made up of people from all walks of life, racial groups, ethnic minorities, sexual orientations and socio-economic categories. The world needs to know this, that we are not merely what is represented on Jerry Springer or the plethora of other television talk shows (although many of these people are part of our Community) but that we are actually a reflection of society in general. That's what the Outreach speakers do and they are to be commended for this very worthwhile service they are performing. As I have mentioned previously, I will be updating our Speakers Bureau list of people who would like to participate in the next few weeks. In the August Newsletter, I will be enclosing a speakers information form for those of you who have an interest in being involved. We need people from all areas of the region as we have requests from all over to speak. In the meantime, if you would like to get your name on the list sooner, drop me an e-mail and I will send you a form to complete. We want to be ready and able to cover the fall speaking semester by the end of the summer with a new crop of speakers, to compliment our more experienced ones, to get out there and spread the word.

It is also interesting to note that in many, if not most, cases the same speakers are invited back to talk to previous engagements year after year due to the relationships they have developed with the groups to whom they have spoken. Because of this, the Outreach speaking function is somewhat self perpetuating, con-

tinuing to happen without much effort from those of us responsible for its success. It is thriving on its own momentum and has taken on a life of its own. Just so everyone is aware of the activity level, without any advertising or promotional efforts, more than a dozen different participants appeared at fourteen separate engagements in the months of April and May.....and the numbers aren't in yet for June. They did it on their own volition, without asking for anything in return. They did it for the good of the organization but, more importantly, they did it for the survival of the Community. These people deserve our thanks and our admiration.

Moving on...June is another big month for TGSF. I just left Kimo's about an hour ago where "LuLu's Really Big Blue Shew" was still raging on. It looked as if everyone was having a grand time and the turnout was terrific. This next weekend is the culmination of Pride Week in San Francisco with the world famous San Francisco Gay, Lesbian, Bisexual and *Transgender Pride Parade and celebration on Sunday. TGSF will host a booth all day Sunday and (of course) be proudly marching in the parade with another of it's eye-catching floats. By the time you receive this newsletter a grand time will have been had by all. This year we attempted to coalesce the Transgender Community in San Francisco by trying to get all of the gender-related organizations to march together in one block of marchers. Our (my) feeble attempt was just too little, too late and it didn't materialize. Next year we are starting early and going to try to convince as many groups as possible we can to march together to show everyone.....gays, lesbians and straights.....the diversity, strength and sheer numbers of the Transgender Community in San Francisco.

In July, TGSF will participate in the 13th Annual AIDS Walk San Francisco being held on July 18, 1999 in Golden Gate Park. It is a 10 kilometer (6.2 mile) fundraising walkathon benefiting the San Francisco AIDS Foundation and dozens of other Bay area AIDS organizations. Celebrities, community leaders and elected officials will be at the AIDS Walk to cheer on the crowd, serve refreshments and walk alongside the thousands of men, women and children expected to participate. Last year, more than 26,000 people raised over \$3.6 million. Funds for AIDS Walk San Francisco are raised by individual walkers who seek sponsorship from family members, friends, co-workers and neighbors for each kilometer they will be walking. But to qualify for a station in the Team Meeting Area, there must have at least 25 registered walkers representing TGSF prior to July 9, 1999. We need volunteers!!!! If you contact me, or any of the other officers of TGSF, by e-mail, we will forward to you a registration form to fill out to walk in the event. Again, we need at least 25 walkers to qualify for a booth and station...just think of it as another walk in the Park, but for an extremely worthy cause. Volunteers?????

The last topic I will touch upon is that of our upcoming political season in San Francisco. This fall, the voters of this "fair" City will elect a new Mayor...or re-elect an "old" one. I will not try to convince anyone in this newsletter who to vote for or express my personal opinions on candidates. To many, they are already well known. ESPRIT 1999: A PERSONAL VIEW

About 150 people converged on the city of Port Angeles, Washington for the Esprit 1999 Tenth Anniversary Gala, which began on Wednesday, May 19, 1999. This four-day event was sponsored by three of our sister organizations in the Pacific Northwest: NWGA (NorthWest Gender Alliance) of Portland, Oregon, Emerald City of Seattle, Washington, and The Cornbury Society of Vancouver, British Columbia.

Attendees came from all up and down the Pacific Coast: Alaska, British Columbia, Washington, Oregon, and northern and southern California. There were also attendees from Alberta, Canada, Idaho, Colorado, Arizona, and New Mexico. People also came from as far away as Minnesota, Texas, Kentucky, New Hampshire, Hawaii, and even Hong Kong and Spain! Karen Andrews and I from TGSF made the trip from the Bay Area to attend.

Esprit was originally conceived in 1988 by a group of transgendered people in the Seattle area who saw the need for an opportunity for TG and TS folks in the Pacific Northwest to meet, share information, learn from each other and support each other in a safe, open convention-type setting. It is structured similar to California Dreamin', which alternates each year between Southern California and San Francisco, and will again have our group as a CO-sponsor here in 2000.

The presenters included many well-known names in the transgender community. Niela Miller, MS Ed, LCSW, LMHC, is Director of PeopleSystems Potential in Acton, Ma. and has been doing coaching, counseling, consulting and training for thirty years. Mariette Pathy Allen, is a well-known photographer of members of the transgendered community, graduated from Vassar College and holds an M.F.A. from the University of Pennsylvania. Sandra S. Cole, Ph.D., is Professor and Director of the University of Michigan Health System Comprehensive Gender Services Program. Karen Brown, is owner of Fifth Avenue Collection Jewelry. Andrea Gittens has a background in theater and dance.

Judy Osborne is from Seattle, and has attended Esprit for many years and shared her insights and experiences with hundreds of Esprit participants. I attended her workshop titled Blue Monday, the feelings that we share when we return home from such a moving event as Esprit.

Anna Haas, the Chairperson of Esprit '99 and President of Emerald City, has long been active in the Seattle transgender community. In addition to presiding over the conference, she gave a presentation titled The Art of Not Passing, which I attended. It dealt with the issues of having pride in being gender-gifted, how to best cope with yourself and others, and how to make oneself a much happier and expanded person.

Elaine Lerner is a zoologist specializing in animal behavior who teaches biology at the college level and is the author of a biology textbook. She is President of the Northwest Gender Alliance in Portland, and told me that she is also a member of TGSF, and has attended some of our events in San Francisco. She gave a very interesting and informative presentation titled X and Why?: The Biology of Sex and Gender, which I attended.

Kathy Vicken, has been in the "wig business" for over 25 years, and Rita Jacobson is a consultant with Beauticontrol Cosmetics, Inc. I attended their presentations on wig care and makeup.

We need to keep up the pressure. By doing so, I am hopeful that in the next City administration we can make some meaningful headway in the continuing struggle for our basic human rights as transgendered individuals. Things such as more openly transgendered City/County Commissioners, a full-time transgender staff liaison in the Mayors office, mandated sensitivity and diversity training for all City agencies and departments or exploratory funding for the creation of a permanent transgender-specific shelter, job training, risk reduction and counseling facility here in San Francisco are all possible. To accomplish any of these objectives though merely voting isn't enough, we must get engaged in the process and make our presence known. Fortunately, the last part is relatively simple.....at least for many of us. A fundamental reality of politics is that to get something from a politician one must give something...first. If we demonstrate our strength and our commitment to a candidate during the election process, we can then, and only then, extract our due reward after that candidate is elected.

So that's about all there is from the Outreach front....or at least all of it that is appropriate to put into print. If anyone has any questions about the Speakers Bureau, the AIDS Walk, the upcoming election or anything else I can help with, feel free to drop me an e-mail. I'll do my best to get back to you in a "reasonable" period of time.

WHY PHELPS TARGETED TRANSGENDERS

Recently it was reported that Rev. Fred Phelps, the vitriolic leader of the Westboro Baptist Church of Wichita, KS has planned to protest transgender medical providers starting in Trinidad, CO. Trinidad has become well known within the transgender community as one of the main places in the US that perform sex reassignment surgery or SRS. Also targeted is Dr. Stanley Biber, a surgeon who has performed many SRS operations.

Rev. Phelps has become infamous in recent months for his loud, noisy protests at gay funerals and Pride parades by sporting large signs decrying homosexuality. He is also operating a controversial website which has drawn outrage worldwide from the TGLB (Trans-Gay-Lesbian-Bisexual) community. Until now, Phelps' had been protesting the larger gay-lesbian "mainstream."

Why the sudden change of targets? Back in March, San Francisco Mayor Willie L. Brown conducted a mass same-sex commitment ceremony in San Francisco's newly renovated City Hall. Phelps and his protesters were greeted by about three dozen or so very energetic and vocal counter-demonstrators. Several notable personalities including religious leaders from various churches and Supervisor Mark Leno also addressed his support the counterdemonstrators.

The most vocal and visible component of these counterdemonstrators was the transgender community led by TRUE, CAPE (California Alliance for Pride and Equality) and TG-RAGE, a direct-action organization based in San Francisco. While Rev. Phelps' followers preached their brand of hate-filled gospel and waved their signs saying "God Hates Fags," the counterdemonstrators responded with a colorful rainbow of signs calling for love, inclusion, and expressing a desire for peace and harmony.

Some transgenders say that we should not call attention to ourselves. They have said we should leave well enough alone. This is exactly why we are being killed. Secrecy and silence allowed the KKK to flourish in the Deep South and kill African-Americans with virtual impunity. We have suffered in silence for fear of calling attention to ourselves. Also, there is the fact that eventually we would have attracted their attention anyway. The TG community has been becoming more vocal and organized, primarily via the Internet.

TRUE and TG-RAGE have been quite vocal in the fight to publicize the terrible wave of violence that has plagued the transgender community. The wave of violence in recent months has seen the death of at least one transgender per month, and those are only the ones that are publicized. Many TG murders are misreported as a gay-bashing. Most are simply ignored.

The kind of violence that is perpetrated against us is up-close and personal. We don't get killed by snipers, we get raped, stabbed, bludgeoned, burned and smashed into a pulp. In other words, not just killed, but annihilated. A TG is at least 10 times more likely to be murdered than any other group, including young adult male African Americans. Perpetrators rarely serve real time. The courts reward them with light sentences. After all, it's just one less fag.

What frightens us here at TRUE is the ominous spectre of harassment and intimidation of both transgenders and providers by violent fanatics who subscribe to the brand of hate peddled by Rev. Phelps and other religious extremists. Remember Operation Rescue? Are TG clinics and SRS surgeons going to be targeted as

WBC TO PROTEST BIBER

Westboro Baptist Church, a group known, somewhat, for its opportunistic use of gay deaths as venues for anti-gay protests, including Matthew Shepard's funeral, has found a new target — transgendered individuals and their care providers.

A press release, taken from the Westboro Baptist Church web site, www.godhatesfags.com, is the first time that this group has opted to attack transpeople, rather than more mainstream gay and lesbian events.

"For lucre, (each pervert customer fetches some \$25,000 plus to Dr. Biber and crew, and thousands more to the general economy of Trinidad), this evil man and his Trinidadian neighbors-for-profit blaspheme God and desecrate the apex of His creation. 'Have ye not read,' says Christ Jesus, 'that he which made them at the beginning made them male and female, And said, For this cause shall a man leave father and mother, and shall cleave to his wife; and they twain shall be one flesh?' Mat. 19:4,5. To satisfy animal lust and raw greed - nothing more - this Biber-Trinidad synergism of evil will veto God's work: make male female, and female male."

As one can tell from the release, a mixture of obscure scripture passages are provided, which only serves to confuse the issue at hand. It also shows that the Westboro Baptist Church is having difficulties figuring out how to protest against transgendered individuals.

"While having an argument with one of the 'Phelpsians' in San Francisco, I was questioned with 'Are you a man or a woman?'" said Gwen Smith, a bay area transactivist, "When I replied with 'neither' he had no formulated response, and no scripture to quote at me... his only response was to call us 'perverts.'"

Some are calling for a trans presence in Trinidad, to counter the Westboro protesters.

"Personally, I can't think of a better reason to go to southeastern Colorado on July 4 than to confront Phelps." said Katrina C. Rose, a Houston-based transgender activist who has been critical of Phelps for a number of years.

"Apparently, Phelps either doesn't know or, more than likely judging from his writings, doesn't care that if not for Dr. Biber's transgender clinic, Trinidad's only hospital would have closed its doors long ago. I'm not Christian, but someone should ask Phelps if his planned protest is, in fact, what Jesus would do."

abortion providers are? Are our providers going to have to live in a climate of fear from potential terrorism? Are we going to have to run a gantlet of intolerants screaming "pervert" or worse just to get a refill scrip for our hormones? I shudder to think.

NGLTF Will Not Support ENDA

[Washington, DC: 29 May 99] The National Gay & Lesbian Task Force (NGLTF) announced on Tuesday (25 May) in an address to attendees at National Gender Lobby Day that NGLTF would not support the Employment Non-Discrimination Act (ENDA) unless it includes protection for gender expression. Currently the bill, sponsored by the Human Rights Campaign (HRC), contains language that protects employees only for sexual orientation.

Betsy Gressler, NGLTF's Deputy Political Director, told transactivists, "You will be lobbying a number of important issues including the Hate Crimes Prevention Act and ENDA. The hate crimes act is an important step in ending violence against gay, lesbian, bisexual, and transgender people and we support it fully.

"NGLTF will not endorse ENDA without the inclusion of transgendered people. [ENDA] needs to be amended and that is part of the important work you have to do while you are here. We need to educate members of Congress about the importance of transinclusion AND the importance of this legislation."

This statement marks the first time a national gay organization has publicly avowed to withhold support from ENDA over the issue of gender.

Transactivists call attention to a survey by NGLTF, the Center for Lesbian Rights, and GenderPAC that showed 28% of GLB respondents reporting job discrimination based in part on the way they expressed gender. GenderPAC has argued that gender expression must be in ENDA, not only to protect trans-workers, but also gays, lesbians, and bisexuals who are gender-different.

HRC, while expressing support for gender rights, remains steadfast against transinclusion. It pledges that ENDA's wording will remain unchanged.

QUILL Editorial Note

This issue came up recently in Ohio, when language for a bill currently in preparation was originally not inclusive of transgendered people, as it offered no protections on the basis of gender presentation. As a transgendered person myself, in the position of Chair of the Equality Begins at Home - Ohio Lobby Committee, I didn't feel at liberty to take a position as to whether we could support the bill as written. That would have been a conflict of interest. This conflict was resolved very quickly when the other Lobby Committee members (none of whom were transgendered) expressed that they would not support the bill without gender presentation language. One member was quite outspoken when she told the legislator not to throw us bones with no meat!

I was initially surprised at my committee's stance on this issue. It was certainly based on part on the strong solidarity we have developed here in Ohio between *all* of the sexual minorities, but it was also based on commonality of interest. Indeed, about 1/3 of all GLB people have experienced employment discrimination based on their not-so-straight manner of presentation, irrespective of their sexual orientation. These people would remain vulnerable without the same language that is needed to protect transgendered people.

The NGLTF is to be commended for its forward thinking. There are many ways in which GLBT people fail to fit into society's molds of "male" and "female," and sexual orientation is only one of them. Perhaps as HRC's constituency continues to broaden to include people with less mainstream manners of presentation, they too will see the need for language that is protective of gender presentation. Until then, I suspect HRC will continue to undermine the work we transgender activists are trying to do in our pursuit of civil rights.

Two physicians who are well-known in the transgender community were there. Dr. Douglas Ousterhout, is a Professor at the University of California, San Francisco, and specializes in facial reconstructive surgery. Dr. Toby Meltzer, is an expert in Sexual Reassignment Surgery for female to male and male to female patients. Also Michelle Mordaunt, M.S./CCC-slp, who is on faculty at the University of Washington Speech and Hearing department, gave a presentation on voice therapy for feminization, which I attended.

In addition to the workshops, there were luncheons, dinners, and a lingerie fashion show. During them, we met some of the people who had started Esprit, and one who had attended all 10 of the conferences! These were great times to get to meet people. I even met a wife of a crossdresser who was attending, who was wearing a dress with the identical yellow gingham skirt!

By far the most important thing about attending Esprit was the people there. Many of them I had met during my trip to Washington last August. Many more I met for the first time in person. There was a total of 22 of us there who had first met in the TG Forum chat rooms, and one person from Kentucky had even made a special trip to meet those of us from the West Coast after first meeting many of us online!

Even nearly a month after the event, I haven't been able to find words to fully describe my experience there. I still get tears in my eyes whenever I meet in an Internet chat room one of my many dear friends who were there. The first such conference that I had attended was California Dreamin' when it was held in San Francisco in April, 1998. I had just joined ETVC the previous February, and gained a lot from the conference, both in practical things that I learned in the workshops, and in meeting many people in the community, some of whom have become dear friends.

But Esprit was special. Going there was much like a pilgrimage. Most of us were staying at the conference hotel, and really got to know each other both at the formal events and as we got together individually. The graduation ceremony was especially moving. Like our Cotillion, which I had participated in this year as a debutante, every person who was attending Esprit for the first time was recognized during the ceremony. Each of us was awarded a butterfly pin by a "Big Sister" who had attended before. We also were each given a lit candle in a glass holder. I will never forget that moving experience!

I sincerely hope that all of you who are reading this will have the opportunity to attend a conference such as this. Both California Dreamin' and Esprit have been important milestones in my calling as a transgendered individual. Also, sharing the drive to and from Port Angeles with Karen Andrews, during which we stayed with several dear friends in the transgendered community en route and for several days in the Seattle area, was very meaningful to me. I will be forever grateful to her and all of the other people who made this trip possible for me. All that I can possibly do to repay them is to continue trying to help others in the community personally, and to try to help TGSF remain an organization which is open and inviting to everyone in the transgender community, particularly those coming for the first time.

FRANKLY TRANSPHOBIC

[June 22, 1999] Last week, the American Transgender Community was once again incensed when it read the antitransgender positions of openly gay US Representative Barney Frank (D, Massachusetts) in Boston's Bay Windows, a large gay and lesbian newspaper. In the article, which focused on the NGLTF's withdrawal of support for Frank's Employment Non-Discrimination Act (ENDA), Frank reiterated his long-standing resistance to legislating for transgender employment rights.

Although ENDA was originally drafted with protections based both on sexual orientation and gender expression, HRC convinced Frank to remove gender-based language before the bill's introduction and has worked very hard since then to ensure the language is not amended back in. In stark contrast to HRC's five-year history of lobbying lawmakers not to heed the appeals of transgender activists, spokesperson David Smith stated that HRC would in fact support such an amendment. Smith added, "Our commitment is to continue to work with transgender groups, to do the education work in Congress which desperately needs to be done." Vanessa Foster, President of the Texas Association for Transsexual Support comments, "We've seen how they work with us. We would fare much better without their 'educational' efforts!" Ms. Foster's views are typical of transgender activists, most of whom have long regarded Barney Frank and HRC as adversaries. HRC has also fallen into disfavor with other national GLBT organizations, which have all advocated strongly for transgender rights.

While the hole in ENDA's language obviously leaves the entire transgender population unprotected, Frank and closely allied HRC have long been aware that many GLB people would remain subject to the same discrimination under ENDA. According to a recent GenderPAC/NGLTF survey, gender expression was identified as an important factor in 37% of employment discrimination cases among GLB people. Most typically, gay men would be targeted for appearing or acting too "prissy" or "gay" and lesbians for appearing or acting too "butch."

What has particularly angered the transgender community is that Frank, in his zealous opposition to transgender employment protections, has now invoked an argument used successfully by the Religious Right against the GLB population. Said Frank, citing some alleged "activists' handbook," "I've talked with transgender activists and what they want-and what we will be forced to defend-is for people with penises who identify as women to be able to shower with other women. There are no votes for that. And if that is the price for this bill, it is wrong." Says Jessica Xavier, National Director of It's Time, America!, "Frank seems to forget that the specter of gay soldiers showering with straight soldiers was enough to defeat the Campaign for Military Service (a.k.a. "Gays in the Military") back in 1992 and 1993."

Of course Frank's claim is ludicrous, considering that a pre-operative male-to-female transsexual is so self-conscious about her anatomical incongruities that group showering would never be considered an option. "To my knowledge, that has never happened, except in the case of one female-to-male police cadet who was required to shower with other men," said Cathy Platine, Director of the Midwest Transsexual Alliance. She added, "I don't want to shower with other women or peek under stalls in the restrooms. I just need to pay my rent and feed my cat. If that means I have to squat behind the dumpster, then so be it!"

Ridiculous though it may be, Frank's argument does great harm to the entire GLBT rights movement. Indeed, what people

fear most in public toilets and communal showers is sexual imposition, which is something a straight man would more likely fear from a gay man or a straight woman from a lesbian woman than either would fear from a transgendered person. It is also far easier for the Religious Right to invoke visions of limp-wristed gay-boys showering with burly heterosexual men, waiting for the soap to drop — or lesbian athletic coaches admiring the slender, wet bodies of their nubile young students — than to concoct salient images of situations involving transgendered coworkers.

According to It's Time, America!'s Ideology Chief, Courtney Sharp, "Since Frank has now brought up the 'communal showers issue' it will be fair game for the Religious Right to use to try to defeat ENDA. After all, some companies hire teenagers for part-time work and these teenagers will be placed in the position of taking communal showers with gay men and women. When you start hearing all of this nonsense from the Religious Right, just remember the first salvo regarding communal showers was fired by the gay representative from Massachusetts who was defending his position for denying equal employment rights to transgendered people."

FIVE YEARS OF FIGHTING

July 28th, 1999, makes the 5th anniversary of fighting with the Human Rights Campaign (HRC) over including transgenders in the federal Employment Non-Discrimination Act (ENDA).

On that date in 1994, Phyllis Randolph Frye of Texas and Karen Ann Kerin of Vermont went to Washington, DC, representing the International Conference on Transgender Law and Employment Policy (ICTLEP) to determine why transgenders had been intentionally omitted from the language of the ENDA Bill. We were told that the problem was the HRC. Nothing has changed.

Barney Frank plays the Bathroom Card to Keep TG's Out of ENDA

U.S. Rep. Barney Frank, D-Mass., one of ENDA's sponsors in the House, said NGLTF's decision will have "no impact" on the fate of the bill.

"I respect NGLTF and I'm glad to work with them, but no congressional votes will be lost" because of the group's decision not to support the bill, said Frank. He added that if ENDA was rewritten to include explicit protections for transgendered people, the bill would have "no chance whatsoever" at passage. In fact, the bill's chances now are not particularly good, Frank said.

"It's not as if this is a truck moving along at 60 miles-per-hour and they are asking us for a ride. This is an uphill climb. We can win, but it irks me that fighting for this bill has become less important than amending it," Frank said. "The votes are there. But the Republican leadership [in the House] won't let it come up for a vote. If [House

Minority Leader Richard Gephardt becomes Speaker in 2000, the bill will pass ... [As long as the GOP controls the House] there is virtually no chance."

Unlike the House, the Senate can bring a bill to a vote without leadership approval. In 1996, the Senate fell one vote shy of passing ENDA. Frank and Christopher Shays, R-Conn., are ENDA's sponsors in the House; in the Senate, Sens. Edward Kennedy, D-Mass., James Jeffords, R-Vermont, and Joseph Lieberman, R-Conn. are the sponsors.

Isaacs said NGLTF is considering sponsoring alternate bills that are more inclusive than the current ENDA. She said the Human Rights Campaign (HRC), the gay political organization that spearheaded ENDA, was "aware from the beginning" that the NGLTF was committed to transgender inclusion, and so ENDA, in its current form, was unsatisfactory. "There were no mysteries," she said. NGLTF for the past several years has included the anagram "GLBT" (gay, lesbian, bisexual, transgender) to all its releases and materials.

But HRC spokesman David Smith said HRC did not expect to lose NGLTF support. "It surprised and saddened us and obviously we are very disappointed," he said. "There was little discussion. We plan to continue to push for the bill in its current form. It's sad that the Task Force chose to do this."

He said HRC has "known for a long time" that several groups had concerns about ENDA's limitations.

"Our commitment is to continue to work with transgender groups, to do the education work in Congress which desperately needs to be done," Smith said. "If an amendment was added to include transgender [discrimination], we'd support it."

Smith agreed that the current Congress is not ready to accept a transgender-inclusive ENDA. "This bill is where Congress is. We've heard criticism that the [current] bill doesn't stand a chance; well, the bill in its current form continues to defy conventional wisdom. We believe the votes are there and we will press for a vote in this Congress."

Frank said he disagrees strongly with the "notion that you don't accept a partial measure" when trying to legislate against discrimination. "The Americans With Disabilities Act (ADA), for one, protects gay men with AIDS but not lesbians and gay men without AIDS. Should I not vote for it? ... In 1976, [former state Rep.] Elaine Noble and I purposely did not push to have gays and lesbians included in the equal rights amendment to the [Massachusetts] Constitution because we knew it would lose. It's the only way to do it. The notion that you don't support [a bill with] some protections because it doesn't include all just isn't clear thinking."

Frank said including transgender protections in ENDA is far more complicated than, say, inclusion of transgender persons in the federal hate crimes act, which Frank supports. The current ENDA would protect transgender individuals if they are discriminated against because they are gay or lesbian or perceived as being gay or lesbian, he said. But there are workplace situations—communal showers, for example—when the demands of the transgender community fly in the face of conventional norms and therefore would not pass in any Congress.

"I've talked with transgender activists and what they want—and what we will be forced to defend—is for people with penises who identify as women to be able to shower with other women," said Frank, citing the activists' handbook which states that a person's declared gender is the one by which he or she should be recognized. "There are no votes for that. And if that is the price for this bill, it is wrong."

TS/WOMEN'S MOVEMENT

In Djadi-Dugarang, the newsletter of the Indigenous Social Justice Association, Ray Jackson tells the story of Belinda (not her real name), a male to female transgender. In late 1997, Belinda was arrested for drug possession and sent to the Metropolitan Reception and Remand Centre at Silverwater in Sydney's west.

Despite living as a woman, and having all the physical appearances of a woman, Belinda was placed in a men's prison because she was born a male. Since she was regarded as "vulnerable", Belinda was placed in the maximum protection pod home also to rapists, paedophiles and other inmates in need of special "protection". The only concession the jail authorities made to Belinda's situation was allowing her to stay in a single cell. Within three days of being jailed Belinda had been raped twice. She hung herself on December 27 that year.

Belinda's story highlights the oppression female transsexuals suffer. By living as women, transgender women are subjected to the violence, sexual harassment and sexist assumptions that all women in this society are. Transgender women who want to organize against this oppression should, therefore, be considered part of the women's liberation movement.

Unfortunately, some feminists oppose this view. In the 1998 women's edition of the Royal Melbourne Institute of Technology student newspaper, *Catylist*, Jess Whyte argued, "There are several reasons why women may feel uncomfortable with the notion of transsexuals using women's-only space."

"The strongest of these is a belief that a person who has lived their whole life as a man could not possibly be free from patriarchal conditioning. It is this conditioning which teaches men that they are superior to women and causes men to exploit and oppress women that women's-only space seeks to protect women from."

Germaine Greer argues along similar lines in her latest book *The Whole Woman*. The 1999 National Organization of Women Students Australia (NOWSA) conference organizing collective voted to exclude transgender women from the collective and last year, the Perth Reclaim the Night Collective also decision to exclude transgender women.

The argument that female transsexuals have benefited from "male privilege" is, however, debatable. Belinda clearly was not a beneficiary of "male privilege" when she was jailed in a male, maximum security prison and raped. Nor would she have thanked her birth gender as she grew up struggling to reconcile what it meant to be a "man" with her deeply held conviction that she was a woman.

Although they are born as males, female transsexuals have little access to the privileges of being male. When they start to live openly as women they are harassed, intimidated, rejected and isolated for doing so. Because female transsexuals also suffer from sexism, their experiences become intertwined with those of all women in a sexist society. This is an objective basis for their participation as equals in the feminist movement.

Sex inequality arises from women being locked into the institution of the family as unpaid laborers in the home and those responsible for child-care and aged care. Upon this economic base rises sexist ideology which seeks to legitimize the family as the only "normal" form of social organization and stereotypes women sexually, physically and intellectually so as to justify maintaining their economic and social dependence on men and/or the state.

Female transsexuals are no less the victims of this sexist ideology and discrimination than other women. They are judged by their appearance, subjected to sexual and other forms of violence and denied equality with men in the work force.

This does this mean that transgender women suffer exactly the same oppression as other women. Their oppression comes from the same source (sexist society), but is not experienced in exactly the same way.

Transsexual women are also oppressed on the basis of their perceived sexuality: regardless of whether they have sex with men or with women, they are considered sexually "deviant" because transsexual sexuality (regardless of sexual orientation) undermines the sexist ideology that sex (for women) must be tied to reproduction.

Transsexuals also raise demands for democratic rights which are specific and additional to those raised by the women's liberation movement: the right to change their gender in legal documents, access to gender-reassignment medical care, against discrimination in work and so forth.

Beneath the debate about whether or not transsexuals are benefactors of "patriarchy" lies the question of what defines a woman. Some of those who want to exclude transsexual women from women-only space have argued that they are not "real women" (it is asserted that women-only space is for "women who bleed").

But as Simone de Beauvoir explained, "One is not born but made a woman". That is, gender roles are socially constructed. From a young age we are punished for behaving in ways inconsistent with what sexist society deems appropriate for our gender. Girls who "play like boys" are tom-boys and boys who "play like girls" are sissies. These taunts are used to pull young people into line and teach them what behaviors are deemed appropriate for their gender.

Reducing what defines a woman to biological characteristics alone, by ignoring the social construction of "womanhood", is scientifically invalid. Defining feminist consciousness as something only those people with female sex organs can have is equally invalid. Transsexual women whose treatment as women in a sexist society leads them to fight against women's oppression are, and should be considered, part of the women's liberation movement.

Some feminists also argue that transsexual women actually reinforce gender roles by adopting behavior and attire that is stereotypically feminine. For example, Whyte writes, "For a man to change his sex in order to fit into stereotypical feminine gender roles is to legitimize society's construction of such gender roles".

This perspective lays the blame on the wrong shoulders. Social institutions, not individual transsexuals, create gender roles for men and women. In that light, it is not surprising that transsexuals, when they adopt the opposite gender, adapt to some of the most obvious social expectations of that gender. Rather than legitimizing rigid gender roles, transsexuals simply reflect the mass acceptance of these roles, revealing that to overcome them will require collective struggle.

Feminists need to oppose those who attempt to exclude female transsexuals from women-only space. While women like Belinda are dying behind bars, no woman is free. Only by fighting together can we overcome the sexism in society that creates such rigid gender roles which oppress all women.

For example, as a transman who has not had genital surgery, it is very dangerous for me to shower w/ non trans men. Same with being housed in male prisons, in with the general population. So, please make sure that your recommendations are both MTF and FTM specific, instead of lumping us into a one-size-fits-all policy recommendation.
