#### SPEAKING OF HOLLY AND ANDY, OR WHEN DRAG WAS IN FASHION

Rock music concertgoers of the mid to late 60's were in for quite an experience at a showing of Andy Warhol's *Exploding Plastic Inevitable*. It was a raucous multimedia showing of lights, movies, slides, and audience participation behind the overwhelming sound of the Velvet Underground and the haunting voice of Nico. And among the band and audience were several beautiful dancing drag queens touring with the group.

Andy Warhol regarded his "drag queens" as his own sort of groupies, and used them as a final assault upon his audience. ("Drag queens" is used in quotes because it appears evident that some of them were really TS's.

Warhol: "As late as '67, drag queens still weren't accepted in the mainstream freak circles (I love it!). But just like drugs have come into the average person's life (sadly), sexual blurs did, too, and people began identifying a little more with drag queens, seeing them more as 'sexual radicals' than as depressing losers."

The three main characters in Warhol's DQ assemblage were Woodlawn, Jackie Curtis, and Candy Darling.

Jackie played being a woman like it was a comedy. The act took on overtones of reality in 1968 when she began taking hormones and began electrolysis. Asked why she was going all the way, she replied: "It's much easier to be a weird girl than a weird guy." (No comment!)

You can check out the underground art scene in Warhol's book, *Popism--the Warhol '60's*. The book is available in the arts/entertainment section of most good bookstores, or in some libraries.

#### FOR ADDED READING

*Making Tootsie*, by Susan Swarkin, tells the story of Dustin Hoffman and the filming of *Tootsie*, the movie that was such a big hit in 1983. Hoffman, of course, plays out-of-work actor Michael Dorsey who becomes "actress" Dorothy Michaels and lands a part in a soap opera.

While shooting some scenes for the movie, Hoffman is said to have fooled fellow actor Jon Voigt, who didn't know Dustin was Michael playing Dorothy. Voigt apparently has trouble telling the boys from the girls.

In *Midnight Cowboy*, Voigt, as the naive western stud who hooks up with Ratso Rizzo (Hoffman), gets involved with a couple of FI's. And it's Rizzo (Hoffman) who sets him up with the "date".

Two other books worth checking out are *Midnight Movies* by Hoberman and Rosenbaum and *Blake Edwards* by Peter Lehman and William Luhr.

*Midnight Movies* as its title implies, is about many of the cult and other Grade B movies that often featured impersonation or crossdressing.

Published by the Ohio University Press in 1981, *Blake Edwards* is obviously about the movie director and husband of Julie Andrews. Cross-dressing plays a key role in several of Edwards' movies, and much space in the book is devoted to his use of it.

His 1967 movie *Gunn*, based on the Peter Gunn TV (television, that is) detective series, has one of the key roles played by a female impersonator, Marion Marshall. He also uses an impersonator in *Revenge of the Pink Panther*, one of the great Peter Sellers' series.
