

Counseling Center undergoes changes

Seattle--The Seattle Counseling Service for Sexual Minorities has been undergoing administrative and program changes: many of the core staff persons are devoting their energies to fund raising. As of January 1, 1975, the SCSSM is without a funding base. The King County Mental Health Board had previously this year refused a funding proposal for the 1975 budget. Without a \$6000 operation base, the counseling service will have to close its doors.

Joe Braid, Pat Haggerty, Sam Deaderick, Robert Reinhart, and Chuck Harbaugh are among some of the more active persons working on funding proposals. The staff has arranged for the advice of outside grantspersons to help organize and direct the funding drive. A few specialized, and as of yet, undisclosed funding sources are the focus of this push.

The need for monies is "critical, very critical--like we are fighting for our survival" according to staff counselor, Chuck Strago. Strago has been instrumental in restructuring staff and volunteer time in order to allow for evening planning meetings, fund-raising events and general brain-storming.

Counseling Center locates building

Seattle--The Seattle Counseling Service for Sexual Minorities with the help of Seattle Mental Health Services has located a building two blocks from its present location. The building is currently owned by Seattle Mental Health Services who is apparently willing to sell it outright to the Counseling Center by allowing the Counseling Service to assume the current mortgage which requires payments of about \$100 a month.

The property on which the Counseling Service is presently located is being bought up by Seattle Mental Health Services which needs the area for expansion.
