September Program: Discovering Your Femme Voice

We are fortunate to have Laura Winstin at our next meeting to help us "discover our femme voice." Laura is a professional voice coach and owner of The Actor's Voice, a studio for theatrical voice and acting. She has a Master of Fine Arts from DePaul and had been in theater for about 20 years, directing and acting, with credits in New York and Chicago. She is currently finishing up a Master's degree in education, with the goal of incorporating arts into education. She has worked for several years with transgendered clients teaching vocal modulation and inflection.

A woman's voice can be sultry, rich, breathy, expressive, emotional, sweet, not-so-sweet, or any combination of the above. But equally important in conveying her feminine image is her inflection and mannerisms. A woman speaks with her whole body, not just with her voice.

So... Do you look like Demi Moore but sound like Sly Stallone? Is your femme voice a cross between Monty Python and Minnie Mouse? Do you waver between a ridiculous falsetto and a rusty hinge squeak? Have you given up altogether on trying to sound more womanly? If you answered "yes" to any of these questions, then this program is for you!

And while we're at it, free Willy, too, before they make another sequel. Now that I have your attention, I want to inform you of a financial proposal that the executive board approved in a meeting on August 26. Although we currently have money in the checking account, the board wanted to take measures to insure that we continue having money in the checking account. To put it bluntly, if it weren't for the fact that we made some money from the 'Holiday en Femme', our checking account would probably be at zero now - nothing more, nothing less. Therefore, you will be asked to vote on the following proposal at the September meeting:

1) Increase meeting fees according to the following schedule:

Newcomers (first meeting)	\$5
Newcomers (2nd & 3rd meeting)	\$10
Newcomer couples (first meeting)	\$7
Members	\$10
Member couples	\$15
Non-members	\$15
Non-member couples	\$20

2) Increase annual dues to \$24

For the average member, this proposal means that the meeting fee stays the same and the annual dues go up \$4. One reason why I would like to have the dues at \$24 is to make it easier to pro-rate for anyone who joins in the middle of the year. As for charging newcomers a meeting fee, the board discussed this at some length and decided that asking \$5 or \$7 will not prevent a newcomer from coming to a meeting. If a newcomer decides not to attend a meeting, it's because she's terrified, and not because we're asking for 5 or 7 dollars. The meeting fee for member couples is being increased under this proposal. Currently, spouses attend for free and only the member pays the \$10 meeting fee. Now, we are effectively asking spouses for a \$5 meeting fee. As for non-members, it is hoped that these fees will encourage them to become members.

We hope that the increased funds that this proposal provides will enable us to have something for emergencies (if the hotel closed tomorrow, could we afford a more expensive one?), as well as money for programs (wouldn't it be nice to occasionally get a paid speaker or to occasionally hire professional entertainment for our meetings?). The board approved this proposal unanimously. We hope the membership will agree to pass it.

In other news, last month's rain storms prevented Mary Ann Foster from appearing at our meeting as planned. Instead, we heard from several members about their own spiritual journeys and how searching for your feminine soul is a spiritual journey. I would like to thank everyone who shared their experiences with us. The big news of the night, for those who hadn't already heard it, was the passing of an ordinance by the Evanston City Council to prohibit gender discrimination. We have to thank "It's Time, Illinois", for that. If you don't belong to "It's Time, Illinois", I urge you to do so. At least give them a donation to help them continue their work. They hope to get the Chicago City Council to approve an <u>ordinance similar</u> to **2**

Magic in Evanston

There was definitely something different in the air that night, an intangible quality that is just on the edge of consciousness, one that you cannot quite put into words. Was it something out of *A Midsummer Night's Dream*? Were all of the players enchanted? Whatever it was, it was drama of the highest degree. Magical is the only way I can describe it.

You've heard about the historic vote of the Evanston City Council. For those of us who were there on that balmy evening in July, it was a highly emotional experience. Until a few months ago, most of the aldermen had probably never even heard the term "transgendered." But that night, they spoke about the discrimination we faced, the hardships of being differently gendered, and about the need to guarantee us fair and equal treatment under the law. Who would have imgained that we would be listening to politicians make such speeches?

Joe Kent, Chair of the Human Services Committee, gave a most beautiful speech. The depth of compassion that he poured into his words, and the understanding of our basic humanity that he conveyed so eloquently, moved several of us to tears, myself included. He said that Evanston had a chance to take a leadership role with passage of this ordinance, and that there are not many chances like this for the Council to make such a decisive difference in individual's lives. "Council cannot take away the pain of transgender individuals or do anything about the confusion they feel as they go through life. One thing the Council can do is provide protection in Evanston." He even promised his support as we seek recognition in other communities.

I will never forget when Gene Feldman answered another alderman's suggestion that employment discrimination be dropped from the bill, saying, "That would cut the heart out of the ordinance. To deny protection against discrimination in employment would be to undercut the very purpose of this amendment." He spoke straight from the heart, with such genuine passion that everyone was touched by it. He said, "If even one person is discriminated against on that basis, it's too much." Earlier this year, I met with Jesse Jackson, Jr. who said something very similar. He said, "As long as one person is denied their human rights, none of us can be truly free." The new law in Evanston will certainly help us gain that freedom.

Arthur Newman compared the significance of Evanston's vote with Supreme Court Justice Brennan's historic civil rights decisions. Noting that this vote was on the first meeting after Justice Brennan's death, Newman said, "Council has a chance to do the decent thing for people who live in society and deserve full protection under the law." Dennis Drummer summed it up when he said that we're just asking for the same thing that everyone else has.

To the People of Evanston: Thank you. You have done a great thing and a brave thing. Certainly this is an important step for Evanston. Imagine... to be the first in Illinois to extend protection to all genderdifferent people. Thinking about the population of Evanston, the numbers in this group could be in the thousands. You will never see that number, however. Even with the protection of the law, the severe social stigma of being "different" will keep most of us from ever venturing out of doors.

Before any people can be free, they need to reach a certain level of pride in themselves. My brothers and sisters will need to be able to stand with dignity and say, "Yes, I'm a trangendered person, and I am proud of it." Evanston has given us a reason to be proud! They have given us a degree of legitimacy that we've had in only a handful of places in the world, and never had in Illinois.

Treasury

I have turned the treasury over to Christine and got her up and running with the bank account software. On August 26th a board meeting was held and the present and proposed budgets were presented and discussed. At the September business meeting a vote will be taken on the proposed changes in Dues and fees.

The National board voted a \$1 increase to the National dues effective 1/1/98 but if you want to renew for two years, it will only be \$30 per year rather than the \$36.

If anyone is interested in running for office, please feel free to send in an article about yourself so we can print it here in the newsletter. Any Full member may run for office and/or nominate some else for office, you may also nominate yourself. You need not be here in person in October to be nominated, but if you can not accept in person you will need to authorize someone to accept for you.

Then in November we will have the elections. If you will not be present for the November meeting, you can obtain an absentee ballot in October.

It is very fitting that Evanston was the first in Illinois to acknowledge our basic human rights. They were the first to acknowledge gay rights. But let me assure you that it will not be the last. We have already spoken with our contact on the Chicago Human Relations Commission, and we will be on their agenda in September. We plan to tell them about our experience in Evanston, about the support that we found within the Evanston Human Relations Commission and City Council, about the elegant simplicity with which the City Code was amended.

And I plan to tell about the wonderful friends that I found in Evanston. For me, that was the most moving part of this whole experience.

I don't think any of us who attended the City Council meeting in July could have been untouched by it. Certainly, none of us in the transgendered community expected to find such understanding and support in Evanston. It was a surprise and a remarkable, magical experience. And I am sure that the Mayor and City Council will never again look at gender in the same light that they did two months ago.

A Spiritual Evening

Those of you who made it out to the August meeting, though the torrential downpour and that spectacular light show in the sky, know that our speaker for the evening, Mary Ann Foster, was flooded out, and could not get there. I saw Mary Ann at Sheila D.'s picnic the next day, and invited her to present her program at our November meeting. It should be a good contrast to the elections that will also be held that night.

In spite of it all, we did have a very feminine evening of sharing our feelings and our spiritual experiences. We started off with the basic premise that seeking one's feminine soul and uncovering one's true being is really a spiritual journey. I want to thank everyone who participated in the discussion, especially Vanessa, Lori, Julie Ann, and Amanda for allowing us a little glimpse into their inner selves.

I also want to apologize to Debbie. As I was scrounging around, trying to figure out how to do the program without Mary Ann, I asked Debbie whether she would like to help me out. Debbie had originally suggested a program on religion. The program on spirituality was my attempt to accommodate as well as not offend anyone. Debbie's response to me was that spirituality is not the same thing at all; it is just an excuse for people not to deal with religion. I guess I was taken by surprise by her reply. I blew her off by saying something like, "Well never mind then. I don't want to deal with that right now."

I'm sorry, Debbie. That was rude of me, and I hurt your feelings. I certainly didn't mean to offend, especially when it pertains to such an important aspect of your life. Everyone's beliefs are equally valid.

I always thought that religion was a codified set of rituals which helped people deal with their spirituality in a socially accepted way. I also thought that spirituality was the broader concept, with formalized religion being only one of many ways that people could relate to a higher power. That is why your response surprised me. So please accept my apologies.
