## In the News

### The LAPD Comes to the Transgendered Community

#### Los Angeles

The LAPD Community Relations Section(CRS) officers Alex Kordis and Howard Yamamoto presented to the Van Ness Prevention Division Transgender Program their desire to promote communication between the LAPD and the Transgender community. Their presence represents a growing commitment on behalf of the LAPD to foster mutual trust and respect between the Department and the transgender community. During their presentation Alex Kordis provided information regarding the functions of the CRS. These functions include: providing an orientation for recruit officers regarding community relations at the Police Academy, coordinating quarterly meetings between the Chief of Police and various community forums such as, Asian/Pacific Islanders, Hispanic, and African American. The CRS officers are also part of the LAPD's Vice Working Group, which meets monthly with members of the gay and lesbian community to deal with the thorny matter of enforcement of lewd conduct laws. The CRS has long served as the official Department liaison with the Gay and Lesbian community, and is now developing this relationship with the transgender community.

During the presentation the matter of Police Misconduct was discussed, especially as experienced by some Transgendered persons in the audience. Officer Kordis outlined some steps a person could take when faced with such conduct. He advised that the individual look for the name of the officer and remember it. Any individual can request to have a supervisor come to the scene and that the police officer has to honor

such requests. The individual can also look for the identifying number found on the door of the police car. Which division the officer is from is important, so the location of the incident will determine the division responsible. The next step could be to report the incident to the watch commander. During the day the individual can also go to the police division and ask to speak to the captain. At the division are pictures of all the police officers, which can help an individual who did not get the name of the officer. Also the incident can be reported directly to internal affairs.

Officer Alex Kordis and Ann Bozzi are the LAPD's official liaisons to the gay and lesbian community, and both officers are interested in working with the Transgendered community. Both officers are at The Village, 1125 North McCadden, Los Angeles on Monday nights from 6 to 8pm. The Community Relations Section Office is interested in working with the Transgendered community and invites you to call if you are interested in having them come to your organization.

## 1944 REVISITED

While rummaging through my late parents documents I came across their 1930 marriage license which was rolled up inside two pages of a January 29, 1944 edition of the now defunct Los Angeles Daily News. The front page of the newspaper was devoted to stories of actions in the Pacific Theater during World War II which were interesting to read considering the history of fifty four years ago. But to me the most fascinating part of the paper was an advertisement on the last page for the May Company department store. Prominently displayed in the full-page ad are three dress and coat styles for women. The advertising verbiage is as follows:

- A. Heading for a new success high - the trig little Shortcoat with more lives than a cat! All wool, in Rose, Lilac, Aqua, and Blue. Half sizes, 16 1/2 - 24 1/2.....\$8.95
- B. Makes and average figure good, a good figure perfect! Pleated frill, white edging, on black or navy wool. Half sizes, 16 1/2 - 24 1/2.....\$10.95
- C. Dove-soft velvet-suede full-length coat - 100% wool! Beautifully detailed in elm-leaf green, lilac, milk chocolate, powder blue. Sizes 10 - 18.....\$29.95

It was amazing to me how in style these fashions would be in this day and age. A little outdated to be sure, but not that far out, and the fabrics were 100% wool, not some polyester blend.

The prices?

In those days the May Co. was considered more upscale and pricey than say, Sears or J.C. Penney's; plus there was a world war going on at the time. Nylon was around during those years too, but it was strictly for use by the military for parachutes and other fabric needs. Nylon stockings were items generally not available to the general public along with real butter, rubber tires, and most products made from metal. I also remember gasoline rationing, meatless Tuesdays, and certain food products, especially meat, that took government-issued coupons to purchase. My mother used to take bacon grease to the butcher shop and sell it. To this day I've never gotten an answer why the Government was buying bacon grease. I did ask my mother before she passed away but she couldn't remember the reason. So it there's anyone out there that knows the answer I'd appreciate it if you'd drop me a line at the PPOC PO Box.

Getting back to the nylon stockings - hey, I'm a crossdresser, okay? Nygons were the items, along with chocolate, the G.I's brought home if they wanted to get on the good side of the women folk. A woman that wore nygons out in

public during the war years was the absolute, and I mean absolute, envy of every other female she came in contact with. Shade didn't matter, and if memory serves me correctly, only full-fashioned seamed stockings were available. During those turbulent war years women took to wearing leg makeup and penciling a seam with eyebrow pencil on the back of their legs to simulate hose. Can you imagine going without pantyhose or stockings in this day and age? Unthinkable for any crossdresser worth her salt.

It was fun looking at that old paper and reminiscing, but you know, nostalgia ain't what it used to be.

### Trans-Murder in Austin

The body of Donald Fuller, 18, also known as Lauryn Paige, was found murdered last Friday in a wooded area of southeast Austin. Two men in a white van were seen earlier that morning near the spot where the victim's body was found. A description of the two men led to composite sketches that were shown on television.

The Austin American-Statesman reports that one of those men, Frank Santos, called police when he saw his picture. He told them he had last seen his brother-in-law, Gamaliel Mireles Coria, and Fuller drive off together Friday morning. Coria's girlfriend subsequently told police that he had confessed the murder to her. Coria, 28, was arrested Wednesday and remains in jail under \$1,000,000 bail.

The victim was dressed as a woman. Said his father of Donald's cross-dressing, "He's been that way all his life. We

always knew he was a little different, and we pretty much accepted it, but we didn't allow it around the house. We just knew he wasn't happy unless he dressed up."

As Lauryn, the victim had often been seen walking along South Congress Avenue, an area where police regularly conduct prostitution raids. Before Coria's arrest, Police Commander Gary Olfers had said, "We are dealing with sadistic killers. There was more than one [stab] wound, and they were brutal in the application of those wounds." The autopsy revealed a cut across Lauryn's throat 9 inches long and 3 inches wide.

"The police description of this murder is heartbreakingly familiar," said Riki Anne Wilchins, of GenderPAC. "Sadistic killers, multiple stab wounds, bludgeoned and/or shot repeatedly... it's a familiar litany of brutally violent acts done to gender-different people: Chanelle Pickett, Brandon Teena, Christian Paige, Deborah Forte, Vianna Faye Williams, Jamaica Green, Jessy and Peggy Santiago, Tasha Dunn... and the list goes on."

## VOICE AND THE TRANSEXUAL: A CLINICAL PROSPECTIVE

### INTRODUCTION

"I am a woman. If I can only speak with a man's voice, my whole identity is shattered." This conflict of visual vs. auditory image is faced by most male-to-female (M-T-F) transsexuals. Because hormone treatment for male-to-female transsexuals does not feminize their voices, as testosterone virilizes the female-to-male larynx, I have treated only the M-T-F transsexual and will focus on this population. An even more profound conflict is their gender identity, described by sexologist Dr. Millie Brown (1996) as the "...deeply held conviction and deeply felt inner awareness that we belong to one gender or the other." The transsexual client experiences a profound "gender dysphoria" because gender identity doesn't match her body. Her chromosomes, hormones, sexual organs, and gender-related messages and expectations of society conflict with her sense of herself as female, even as a child.

Similar gender dysphoria was just reported by Dr. William Reiner, (1997) concerning infant "John" whose penis was accidentally destroyed in a 1964 surgery. Believing gender identity to be neutral prior to hormonal and environmental influences, physicians performed SRS (sexual reassignment surgery), counseling John's parents to raise him as a female. He was not told of his history, yet rejected everything feminine. He felt like a freak. Despite his female anatomy and estrogen treatment, he suspected that he was indeed a boy. His doctors reversed his SRS surgery, and he is reported to be well adjusted with a family and adopted children.

One area of the hypothalamus has been found to be 44% larger in males than in females. However, several studies of M-T-F brains reveal that area to be of the smaller female size, apparent biological basis for gender dysphoria.

There is widespread occurrence of transgender in nearly 1% of the world's population. Written history for centuries before Christ documents transgendered people including Dr. James (Isabel) Barry, the first woman physician under Queen Victoria who lived her full life as a male.

### TREATMENT

Brown & Rounsley (1996) describe how the treatment process for transsexual clients is guided by the 1979 Harry Benjamin Guidelines for Standards of Care named after one of the first physicians treating this population. They contain built-in time restraints and safeguards to include intensive counseling before hormone treatments and at least a year of full-time living as the identified gender before optional sexual reassignment surgery.

### Speech and Voice

There are several types of vocal cord surgery available to raise voice pitch but with mixed results.

In therapy, increase of **fundamental frequency** is a controversial goal with concern that it can be potentially damaging. However, I find practicing a soprano "head voice" to be effective in raising pitch while avoiding the thin falsetto and vocal strain. Playful experimentation with a "Queen Mother" dialect or role playing as Julia Child often elicits the head voice with expanded resonance of a yawn. Gradual adjustments from the dialect to more natural prosody yield a natural feminine voice. Role playing, especially in group therapy and regular practice, with both audio- and videotape feedback, when possible, are valuable. There is about an octave of overlap of the male and female pitch ranges where most of my transsexual clients function well. In fact, the most feminine M-T-F voices I've computed from several private practices approached female mean frequency and pitch range.

Most therapists who treat transgender are more concerned with other speech markers as gender cues.

### Speech Markers Targeted in Therapy include:

1. Increase fundamental frequency.
2. Increase functional intonation range and pitch variability.
3. Use rising intonation after declarative sentence sometimes.
4. Increase breathiness with variability.
5. Add tag questions for consensus; e.g., "Don't you think?" "Okay?"
6. Increase use of modals (can, will, may, must).
7. Use light, yet precise articulation.
8. Use a wider range of qualifiers; e.g., "Such a little," "quite cute," "really rather violent."
9. Use compound polite requests; e.g., "Would you please?"
10. Speak with assured confidence.

Non verbal visual markers include maintaining eye contact, attending to speaker's non verbal cues, using more hand and upper body gestures, sitting closer and occasionally touching the listener.

Clients enthusiastically describe improved interpersonal relations and response when they practice their feminine communication style: Using question forms, seeking accord, and listening more actively rather than giving orders and directives.

### PROGNOSIS

Success in therapy is enhanced when the client cross dresses for the therapy sessions, has a discriminating ear and vocal flexibility, and allows herself to experiment with unusual, non habitual voices.

Incorporating the new voice with speech markers both verbal and non verbal, into her "new true self," the transsexual is able to cross with greater success into her new gender.
