#### The Importance of Winslow

Prior to 1990 the transgendered community was made up of a few organizations which were attempting to provide support, outreach, and a safe harbor for trangendered individuals.

One of the great problems the community faced was finding funding for the programs and projects. There were no funds available from traditional sources, no one knew who we were and we had no credibility. New projects had to be self-funded or abandoned.

In 1990 a group of six individuals met at the Chicago House on Winslow Street in Provincetown, MA during Fantasia Fair and developed a far-reaching program that became known as The Winslow Street Fund.

Since then we have received support from every segment of the community, and from outside the community, and the Winslow Street Fund has become a viable and positive force for our community. All funds donated to WSF are placed into investment grade stocks, bonds and money accounts to grow in perpetuity so this community will always have a source of funding.

The Winslow Street Fund has been able to provide funding for many community projects that might otherwise not have begun or continued.



### The Winslow Street Fund

The Winslow Street Fund is a community based program that was established in 1990 to provide funding for educational and outreach activities that benefit the Transgendered Community.

Winslow Street Fund has made many grants to community organizations and programs. We have also made grants to other organizations and programs when we felt that the programs would benefit the Transgendered Community.

Programs such as Spouse/Partners International Conference for Education (SPICE) and the International Conference on Transgendered Law and Employment Policy (ICTLEP) have used our grants to provide scholarships and services that they would not otherwise be able to provide.

Winslow Street Fund has made almost twenty grants since its inception five years ago. We have shown that this community is willing to open its heart to its own.

Winslow Street Fund has proven itself as a viable and valid force for positive change.

The Fund is administered by a group of trustees who are appointed by the Winslow Street Fund Chairperson, who is appointed by the Board of Directors of IFGE.

#### Common Questions And the Trustee's Response

Q. Does any organization have an exclusive right to the Winslow Street Fund monies? A. Winslow Street Fund is an Endowment fund separate and exclusive of any national organization. The Trustees may be members of various organizations but the charter requires them to act in the interest of the Community.

#### Q. If I give to the WSF will those monies be used for any specific activities? A. All funds donated to WSF are placed into

A. An funds donated to wSF are placed into an investment grade portfolio and cannot be used for any purpose other than the growth of the Winslow Street Fund and Grants.

## Q. How do I know the financial status of the WSF?

A. The Winslow Street Fund publishes its financial statement in various community publications. Specific information about the Fund can be obtained by writing Winslow Street Fund c/o IFGE.

Annually at the IFGE Convention, the Trustees provide a financial summary of the past year's activities.

Q. Can I give stocks, bonds, or other financial instruments rather than cash? A. Yes, and there may be some tax benefits or estate planning options available. We suggest you contact one of the trustees to further discuss these valued and important contributions.
