

KAY SERA: Charles, you are our first profile. You are a highly visible person in the Court and the community at large – what led to the fabulous creation we all know as Coco LaChine?

COCO LaCHINE: I grew up in Manila, and can remember, oh - way back - I experimented with crude drag when I was about ten years old. I had dolls and stuff, and I began to make my own wigs. My favorite costume motif was Hawaiian, both for me and my dolls. I took two-foot lengths of manila rope, tied them together, and, you know, unbraided the strands; teased and frayed it out so it made like hair. My first wig. To complete my Hawaiian outfit I made skirts from newspaper - cut into strips with a waistband at the top, like a hula skirt, you know. My mother found them and threw them out, but I just made new ones. I never wore my mother's or my sister's clothes, just what I made myself.

When I was in high school I learned something about gay life, and in college I began to experiment with drag through friends who were beauticians – hair and makeup people – and dress designers. I was pretty good at art and design and started on my own outfits; this was not like what we know in the Court – the drag scene there was just a kind of blue collar, neighborhood thing – we didn't go to clubs, but beer gardens, to do acts and hang out. But the scene at the beer gardens was lovely, especially late at night, when the bottles started flying.

KAY: When did you come to the U.S.?

Did your coming to New York raise your DQ (Drag Quotient) right away? COCO: Well I came over in 1980, I think, and went to school, had relationships, but kept drag to a sort of Hallowe'en level. Then I added New Year's Eve. And maybe Valentine's day. And in 1987 or 88, I was crowned the Center's first Prom Queen. KAY: That's quite a distinction, considering your roots in a rope wig and paper hula skirt. Where did that lead you (hehbab)?

COCO: I entered the first Miss New York City Pageant, and was first runner -up,

COOKIN' WITH KITTY

Anything goes in gumbo, an African word for okra. Back home in Louisiana no one makes gumbo the same. Try adding a couple pounds of smoked kielbasa diced and sauteed or even fresh gulf shrimp, about 2 pounds medium size uncooked but shelled. Even try adding boiled eggs. Yum, Yum!!!

Kitty's Secret Okra & Chicken Gumbo

- 1 really large yellow Spanish onion
- 1 really large or 2 medium green peppers
- 4 to 5 celery stalks
- 4 cloves fresh garlic
- 1 1/2 to 2 pounds boneless chicken breast
- 2 pinches salt
- 1 pinch ground black pepper
- 1 pinch ground red pepper
- 1/2 cup cooking oil
- 6 cups chicken stock
- 2 cups sliced okra (small mess) or one
- 10-ounce package frozen cut okra, thawed
- 4 green onions, sliced
- 1/2 cup fresh snipped parsley Hot cooked rice or homemade (or deli bought) potato salad
- Chop onion, green pepper, celery, and garlic. Reserve until later.
- Sprinkle boneless chicken breasts with salt, black and red pepper. In a 4-quart Dutch oven brown chicken in hot cooking oil. Remove chicken and set aside. Reserve drippings in Dutch oven.
- Add flour to pan drippings in Dutch oven, scraping bottom of pan to loosen drippings. Cook over medium-high heat 5 minutes, stirring constantly. Reduce

and it was all downhill from there. I had been going to Night of a Thousand Gowns from the beginning, when the Court was just like a club, just a group of friends, and I met (Empress IV) Camille Beauchamps and (Empress V) Razor Sharp who were judges in the Miss New York City Pageant. They asked me to join the Court, to come in with them at that time, and we worked to re-organize the Court into the form it has today. I remember that I set myself a goal, I wanted to become Empress in three years.

KAY: And you were, of course –
Empress VII the year I came into the
Court 1993 – you achieved your goal!
How did your work. at the Center, your
activism, come into play?

COCO: I had been volunteering at the Center since 1984, and became a board member in '89. You know, in those early days of the Center and the Court, GMHC for example was not so big, there was no Dance-A-Thon, the community did not have all that it now has by magic. We all worked for it - trained ourselves as activists by doing, by trial and error. A group of us, Camille, Razor, Saleen (Empress VI) and whoever, began to reorganize the Court with our own money, money lent from the Center, and money we raised from a show Anthony Wong put together at the Roxy. Those of us who organized at the Center provided the organizing skills, the grassroots volunteerism for the HOP Dance on the Pier, The Aidswalks, for many things that people may now take for granted. We spread our experience through the community and became directors of other efforts. I myself was on the board of the Gay Games and am currently a director of GLAAD. I like to set a goal, and I go out of my way to get it, I like to seek people out, offer help, not just sit home and wait for an engraved invitation.

KAY: Drag seems to be everywhere, Coco. I wonder how "mainstream" this will all go before it collapses; I mean in the culture at large. We skip from fad to fad "out there". Yet the transgendered will endure – we're not in it for the money, so to speak.

COCO: We will be the flavor of the month only if we don't keep up the pressure, the work. Fads will come and go. We need to be visible, responsible, professional. We aren't special, we just are. We need to not be afraid, to organize and reach out. We need to educate, entertain, just be there, good and bad. The Court and the drag community should respond to the work that needs to be done. Come to meetings, speak out, write checks, organize and come to events. Never sit back and bitch, there's too much to do! KAY: Thank you for your time, Coco. And thanks for all the hair advice.

heat to medium. Cook and stir about 15 minutes more or until dark reddishbrown roux forms. Watch very carefully because to high heat will burn the roux.

- Add onion, green pepper, celery and garlic to roux. Saute over medium heat for 3-5 minutes or until vegetables are tender.
- While vegetables are sauteing cut chicken into bite size cubes.
- Add 4 cups of chicken stock. Add diced chicken to the Dutch oven. Bring to boiling. Reduce heat. Cover and simmer about 1 1/2 to 2 hours our until chicken gets very tender, adding more stock (or water) if necessary to keep the pot full.
- Stir in okra, green onions, and parsley.
 Cover and simmer 30 minutes longer.
 Remove from heat and skim off fat. Let stand 30 minutes covered after skimming fat.
- Serve over rice or in true Cajun style over a big scoop of potato salad.
