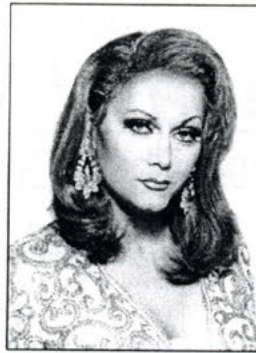

### For Vice President and Board - Tom DeConza

Commitment, Support, Experience, Involvement, Organizational Skills, Fundraising History and Ability, and Time. That's what I feel I can give to The Court.

Since joining The Court in 1994, I have attended all but one general membership meeting. When I was on The Board as a, Director, a Monarch, and Vice President, I only missed only one meeting. When I was diagnosed in 1982, I became very involved in Fundraising for AIDS organizations. As Co-Director of team New York, I met Coco while doing Fundraising for Gay Games IV. Coco told me about The Court and their goals, I knew that I could do a lot with The Court.

The year I joined I was Chairman of the Raffle Committee. That year I was able to raise \$2,300. for our beneficiary. Since then I have Co-Chaired the committee, turned into The Silent Auction, Raffle Committee. This year with the help of many of my fellow Court members, especially Gene Rogers, we were able to raise more than \$9,200 for AVP.

As President of the largest Gay and Lesbian Bowling League for 8 years, I created many Fundraisers, including two

theater parties that saved the members of The Court and my fellow bowlers \$15 and still we were able to donate more than \$700 to The Court. Some of the other events I have created, hosted or organized have been the Annual Holiday Party, the New Members' Dinner, Mamá Bella's Pasta Dinner and Penny-a-Pin AIDS Day Fundraiser with my Empress Gianna, and most recently, Meet the Candidates Dinner. All these events were reasonably priced and raised thousands of dollars for the beneficiaries.

When running Fundraisers and Socials I have always tried to make it cost efficient for our members and our friends. As Emperor, when many of The Court members wanted to attend Toronto's Coronation, I contacted American Airlines and arranged for a Group Fare, saving us 15% off the lowest fare. Last year, as Membership Chair I took the initiative in organizing the trip to The Las Vegas Coronation. The package included airfare, 5 nights at The Mirage and airport transfers. The package made it possible for 23 Court Members and friends to attend. A royal time was had by all.

As Vice President of the Court for the past 10 months, I feel that I have upheld my promise to continually update the roster when new elevations were awarded, correct any changes or correct my mistakes. Because of my flexible work schedule I am able to devote as much time as necessary to execute the duties of the Vice President. No matter how demanding it might have been I have always had time to raise money for The Court. In order to further the visibility of the male dressing members, I held the first all male, live, performance fundraiser. It raised more than \$750 for Mamá, José I, The Widow Norton. For me this is what The Court is all about and most important. Having raised more than the "suggested" \$300, by creating affordable Fundraisers and Socials has been one of my "achieved" goals. They have proven to be inexpensive and lots of fun.

As a member of The Board, I have always felt that it is just as important to support The Monarchs by attending out of town coronations, (I have attended more than 15 across the country), attend Fundraisers, and offer support whenever and however they might need it. Personally, I feel that it's not only about being an officer of The Court, it's about being involved, giving support and raising money and helping out where ever necessary. Since joining The Court, I have always remained focused on what The Court is all about. Been there to help in any way possible, Whether it's in the spotlight or working behind the scenes, that's what I am all about. It is also important that we connect with the new members and the OLD ones. Listening to their concerns, addressing their problems, giving some direction, or getting the new members involved, is also important. whether it is helping a fellow

Court member by securing Raffle gifts, offering a member a place to dress to attend a Court function or just giving someone a lift, I have always been there to help. Having been a Director, a Monarch and a Vice President, I have never taken "time off" or stopped working for our goals. I have always been willing to listen to suggestions, take criticism, and try to work things out in the best interest of The Court. Although I have not always agreed with the decisions of The Board, I feel that it is very important to support those decisions.

If elected Vice President, I will do my best to find ways to make more things affordable for all our Court members to attend out of town Coronations, Fundraisers and Socials. But most of all, I want to raise money, LOTS OF MONEY.

### For Vice President - Michael Barret Jones

Thank you for considering me as a candidate for Vice President of the Imperial Court of New York. Serving as Secretary for the past year has given me insight into how things are run, why things happen the way they do, and more importantly, it has taught me patience and helped me become a more understanding and compassionate person.

The members of the Imperial Court are very good at helping others and bringing joy to people throughout the region. However, I have noticed that we are not nearly as good at helping each other and bringing joy to everything we do. Perhaps part of the problem is that we, as members of an organization, do not get to know each other very well. Certainly

each and every one of us has a circle in which we travel -- that is human nature and it cannot be avoided. I would like to take on the position of Vice President/Membership Chair to help each and every one of our members get to know each other in a more thorough manner.

Currently, the Imperial Court has a New Members Dinner every fall, and occasionally another event or two for the sole purpose of mingling. I think we can do more. I would like to see casual cocktail parties where members can mingle. I would like to see the Lord and Lady Show reinstated and brought into play earlier in the year - perhaps January - so that we're not





meeting people for the first time during Coronation Week. New members can and should be incorporated more thoroughly into every thing we do, from performances to raffle sales to committee work, and it is the responsibility of the Vice President to make sure that they have these opportunities.

Likewise, it is the job of the Vice President to serve as a conduit between the membership and the Board. Frequent contact with individual members can quench the fires of "hot topics" (like the recent by-law change) before they become roaring conflagrations. The Vice President, like every board member, is elected to represent the members, but specifically as Membership Chair, it is also his responsibility to represent the individuals.

I would also like to see our Night of A Thousand Gowns mailing list used as a step off point to increase the size of our membership. The more of us there are, the more money we can raise, the more organizations we can serve, and the more people we can help. Sending mailings to this list several times a year with updates would help us to cultivate a greater public, as would sending them information on open membership dates. We have a great public at Night of A Thousand Gowns, and there is no reason we shouldn't open the door to them throughout the year.

In summary, there are three major tasks I would like to undertake as Vice President/Membership Chair: 1) Bring new members into the fold with open arms, and continue to nurture them throughout the year, 2) Serve more actively as a conduit between the membership and the Board, and 3) Increase the size of the membership through more public events and direct solicitation of our current friends and supporters. I believe I am capable of accomplishing this work plan, and by better serving our membership, help better serve the community around us.

Thank you for your consideration, and I hope you'll give me the privilege of serving you for another year.

## For Vice President and Board - James Palacio

After being a member of the ICNY since 1992, I find myself asking what else can I do? I've been around longer than most of our membership and feel that my vast experience with this organization can only assist in my success as Vice-president or Executive Board Member.

The most important contribution that I can make will be that of being the voice of our general membership. I want members to feel like there's someone on the board they can turn to who will listen and bring up



their concerns. As we all already know I don't hide behind pretenses nor do I "yes" people just to fit in. If I believe in something, I let it be known. Recently I believed an amendment to the by-laws was wrong and with the aid of three fellow courtiers, spearheaded the movement to have it repealed. The proof is in the pudding, the amendment was voted against by a majority of nearly 3 to 1. I like to think that most of my views accurately reflect the majority of the general membership. After all, we are all here together sharing a common goal. And even those who don't agree with my views, should know that I am more than willing to listen to all members and not dismiss them simply because we do not share the same opinions. General members are what make up our organization and are as equally important as Board members. Together we can all work towards a better, stronger and more united court where every person counts.

Another contribution is my being well connected within and outside of the Gay and Lesbian community. I want to utilize these good connections in the form of corporate sponsorship and spread the word of the ICNY. As an actor/actress and with my recent notoriety as "Ring Girl" on the HBO series "OZ", this will enable me to do so in a professional, glamorous and high profile manner. Visibility is the key!!! I want us to become more mainstream and feel that I can help accomplish that goal.

As for my commitment to the court, I've more than demonstrated my love and support for our organization and what it stands for. I've participated in a vast amount of events, chaired and volunteered for numerous committees, attended 4 Out of Town Coronations and 9 NOATG's. I was supporting our cause even prior to becoming a member. I've always believed in the good of the court and feel it's time for me to give back to an organization which has been an important part of my life for many, many years. The position of Vice-president as well as Executive Board Member are not easy ones, but I know I can handle the job and accept the challenge.

## For Secretary - Lynne Walker

I have been involved in the trans community since the early 80s, when I was a member of the Tiffany Club of Boston, but it was not until I moved back to NYC that I became active as a leader. In 1992, I

co-founded the Metropolitan Gender Network (a social and support group for people of trans experience), and served as their first Chair and as Secretary. I wrote and published the newsletter and the annual report for three years, during which time the organization increased in number from five to over forty. The same year I began to work as a volunteer counselor with the Gender Identity Project at the Lesbian and Gay Community Services Center; in that capacity, I facilitate a support group for women of trans experience. In 1993, I co-founded the Greater New York Gender Alliance, (a regional network of drag and trans organizations), and served as the Secretary for three years. In 1994, I was elected to the Board of Directors of the International Foundation for Gender Education (a non-profit corporation for public education and advocacy), and I was elected Chair of the international Congress of Transgender Organizations (an international network of Trans organizations). The same year, I was among the first members of the Transsexual Menace, a political/social direct action and advocacy organization committed to the defense of oppressed trans and drag folk. Finally, in 1995, I co-founded GenderPAC



(a national political advocacy coalition), and served as the first Chair of the Board. During this time, I was also engaged in permanently transitioning from a male to a

female social and vocational role.

Outside the trans and drag communities, I worked as a senior medical administrator for the federal government for quite a few years, and now serve as Operations Director of SafeSpace, a comprehensive 24 hour program for homeless and street youth. I also teach English and Philosophy at a local college. Elsewhere in the 'volunteer' realm, I am fairly active in local church activities, though I have not served as a pastor since the mid-90s.

I'm computer literate, and an accomplished writer and public speaker. It has been a pleasure to speak before crowds, classes, conventions, and church congregations, and I've been published a number of times in trans journals. Moreover, I am a loyal team player: I like to work with other hardworking and dedicated people. My style is understated but ordinarily effective, and I find that I have the ability to organize and present ideas clearly and succinctly, and I can do many things at the same time (see above: work, trans stuff, and transitioning).

I joined the Court about six years ago,



and though I know little about fundraising or publicity, I am glad to be with empowered people who can and do raise so much money and attention and consciousness about our community. Since joining, I have made some of my closest friends here, and I have had the pleasure of travelling to a number of out of town coronations. I've found among my other friends a tremendous respect for the Court and our work. So to get to the point, I feel that I now have time and energy to lend a hand in doing the work.

## For Secretary and Board - David Wallace



I haven't been a member all that long. Many of you don't know me very well. I'll address the present and the future in a letter I'll be sending to everyone soon, but for now I'll focus on charitable endeavors in

which I participated in the past.

In January 1969 I was elected the youngest member of the National Steering Committee of the Student Mobilization Committee to End the War in Viet-Nam. For those of us unwilling to admit to being old enough to remember, the SMC created the Moratoriums, national days of demonstration and protest against the war.

I served for a number of years on the Board of Directors of the ARA, Inc., first as Secretary and later as Vice President. During this time I represented approximately 500 tenants of the Hotel Ansonia in housing court on a nearly daily basis. In conjunction with the Treasurer, I supervised an escrow account in the millions, rent money being withheld from the landlords as part of a rent strike that continued, in one form or another for nearly two decades. I also supervised the incorporation and re-wrote their By-Laws to bring them into compliance with the regulations and standards of the State of New York.

In the last decade I have been active in the Freemasons, a centuries-old fraternal organization which supports and runs charities worldwide too numerous to list. And while I'm certain there's one out there, despite years of looking I'm still the only openly gay Mason I've ever met.

I have participated in other events, of course - AIDS Walks, fundraisers for Broadway Cares/Equity Fights AIDS, Tom Duane's Council campaign and many others outside the gay community - but in the organizations above I played a role of some leadership. As one of the organizers for the recent campaign to repeal certain amendments to the By-Laws I have amply demonstrated my

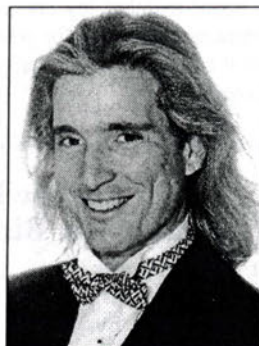
ability to organize and motivate. Even those who voted against repealing the amendments would, I believe, concede that I am certainly competent to perform the duties of Secretary or Board Member. I welcome the challenge and the opportunity to serve in either capacity, should a majority of the membership choose to elect me.

## For Treasurer - Matt Baney

I was invited to join the Court in 1995 when I moved to Cherry Grove for the summer. I met so many wonderful people who were involved in the organization. It seems as if the entire College of Monarchs lived there, from Billie Ann Miller and Philomena to Ran-Dee, Gianna, and Panzi. From these individuals I learned what the Court does and why....we are not just a bunch of people who enjoy dressing up. We raise money for, and awareness of, issues that directly effect the Gay, Lesbian, Transgendered communities. My involvement started slowly from attendance at a number of small local functions, to NOATG, to the honor of being a brother to Empress Panzi and Emperor William. Emperor Chet also honored me with the designation of brother.

The ICNY has given me great opportunities to meet new friends, travel, and provide community service. Now I feel it is appropriate for me to pay back the Court and its members for the years of enjoyment I have gotten from my participation. My professional skills and abilities can best be used as treasurer for this organization. I am currently the financial administrator of a large hospital-based HIV/AIDS program located in the Village. I have a masters degree in business and at the present time manage \$10+ million in funding on an annual basis. I would like to use my financial planning skills to maintain the financial records of the organization and also to expand upon funding streams. I teach classes across the country on grant writing and financial development for non-profit organizations and I would appreciate the opportunity to use this knowledge to benefit the court.

For the last two years I have chaired the tickets committee for NOATG. I have seen first-hand that we are no longer a little group of friends who raise money on a small scale. We are now a large organization that should be managed as a business. Our distribution of money to our beneficiaries represents significant enhancements to the receiving organizations. We brought in almost \$100,000



last year in ticket sales alone, which represents a lot of \$135.00 tickets!!! The record keeping for such an endeavor is extremely time consuming and we balanced out at the end of the event. Thank you's for the assistance of Billie Ann and Philomena.

I have gotten to know almost all of you over the course of the last few years. I have heard the criticisms and praises of seating for the Ball and tried to work with each of you in a fair and timely manner for any issues that have arisen surrounding the event. I think I have proven myself to be approachable, accountable and thorough. I would welcome the chance to bring these traits to the position of treasurer for the Court next year.

## For the Board - Thom Hansen

I am currently serving on the Board of Directors and have served since April 1998. I reigned as Empress for 1998/9. In 1995/6, I served in the capacity of President of the Board. During the time when I was President and this past year, I served as the co-chairperson for the By-law Review Committee.

This past year, the By-laws were amended to allow for an additional person to serve as a Director on the Board, thus increasing the General Membership's direct participation in our organization. This is a great opportunity to bring "new blood" onto the Board with new, fresh ideas. However, I feel that while it is important to bring in new blood, it is equally important to maintain some consistency for the sake of stability. This is why I would like to be reelected to the Board of Directors. I have the experience, the passion and the time to serve ICNY. In addition, having been involved so deeply with the By-Law revision process, I feel I would be of great importance this coming year, as questions may (or may not) arise regarding the By-Laws. I have also been involved in the International Imperial Court System: I am Secretary of the Board of Directors of the International Court Council. I am honored by the fact that I am the only individual to serve on this Council who is not an Heir Apparent to Empress I José, and when I was originally elected to this position, I was the only person to serve who was not a Monarch at one time or another.

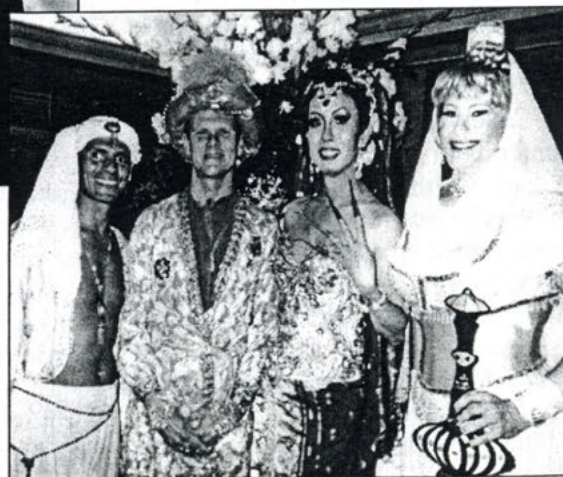


Courts were represented.

Several years ago we learned that Judy's Cabaret and piano bar was a welcome haven for the Transgendered. However, being located on 44th St. on the east side of Broadway, we had only visited them on rare occasions and then for a short respite.

In the Fall of 1998, Judy's closed, only to reopen in Chelsea on 8th Avenue, just adjacent to the Joyce Theater. We stopped by on a Saturday night, and we were welcomed and acknowledged by the pianist, Charlie Lindberg, whose prodigious talent we had formerly enjoyed at the old "Oaks" in the Village.

Behind the retro 90's deco styled bar was the male alter ego of Ruby Rims, the "Red-

hot Mama" drag queen, also an "Oaks" alumna, who is responsible for the "Teddycare" series of shows at Holiday time where by dollars and teddy bears are collected and distributed to children (many with AIDS) in the City's hospitals. Ruby is always fun to listen to..she usually never needs a mike, and makes everyone feel at home. As a professional Drag Queen, she does extend professional courtesy to other "Queens"! We just love that!

We go just about everywhere, (no, Babs does not do White Castle! ..Oh! Oye! Heartburn at mere thought! ), but really like to find places that do welcome diversity, so that all our transgendered friends will feel comfortable. Our first visit included our own Viscountess Morgan Stevens, who is well known as the fabulous Ann Margret impersonator with the big..hair! Flamboyant, yet sensitive to not offending anyone, she is very conservative in choosing public places to visit in her Ann Margret persona.
