For Carol, a vision of an anorexic sized portion of some artfully decorated miniature fowl at astronomical prices, tends to make her shudder when I mention going out to a French restaurant.

For that reason, it took a year after Babs first went to Chez Suzette for dinner with some of the "Jersey Girls" that Carol finally agreed to eat there. She had to be "noodged" several times, and she finally agreed only because we went to see Rose Levine's Female Impersonation show at Don't Tell Mama's, only a half a block away on Restaurant Row.

There is a rustic, yet cozy ambiance, with country French paintings decorating this openly Gay friendly little country bistro on Manhattan's west side. The owners, Gerard and Jeanette welcome all, especially Drag Queens and transgendered ladies!

For starters, we enjoyed both the house salad and the house paté which was smooth and flavorsome. On a prior visit we sampled artichoke hearts which were good. We did have a bit of a problem refraining from the crusty thick French bread, which was good and tasty!

There are always interesting daily specials, but we stayed with some of the regular entrees on the menu. The duck a l'orange was served crisp as requested. The veal cordon bleu was tender and cheesy smooth and tasty. The shrimp scampi, swimming in garlic was as good, though not noteworthy.

For dessert, we only sampled the "standard" varieties. The rum cake and "house" fruit tarte were very good. The creme caramel was a disappointment in

that it was merely a custard and not something thick and chewy and as good as it looked!

Normally we are a bit reluctant to order desserts, for we have to watch the waist line for the next ball or formal, but with their prix fixe dinner being an additional \$6 more than the a lá carte prices, if you order an appetizer and a beverage the dessert is free...so we couldn't pass up a bargain! The recommended dress is casual, but that doesn't mean you can't dress up and be recognized. You will be welcome, so the owners assure us. In the time we last visited Chez Suzette, one of the local transgender groups had held a Holiday party there and they told us they were very

satisfied with the food and service. They are closed on Mondays, and the owners have told us they would love to host a Court function any Monday!

Prices are moderate for the area, the prix fix dinners starting at \$18.95. They advertise real food, and they deliver on their promise. When you bring their advertisement in HX and Next magazines which offers a 10% discount, dinner there becomes a real good deal, a "bon marche"!
