

A REVIEW OF A REVUE * ****** ** * *****





"Bebe's Cabaret Revue" Music Hall, Tarrytown, NY 12/1/84

This was one show that I thought most appropriate to go to "en femme". With my black dress and black high heel pumps and my friend in his black jacket and tie, we were properly attired for a special event. I have never seen female impersonators in the flesh before and I was quite anxious to "see how it's really done".

First we had dinner at the Pickwick Post (a very nice place if you're a crossdresser in Tarrytown - they treated me like a lady) and then went to the show. They had a fine four piece band on stage and the producer of the show, Sylvia, danced on stage in a long white gown slit to the waist. Sylvia is thirtyish with nice legs. She organized this show (she also had her own little local fan club in the back rows) and she kicked off the show by welcoming everyone and introducing the girls. Then in came the sensational Bebe Scarpi. Bebe is a beautiful lady and has been in the business for at least ten years. I think she is a transsexual. Her voice is a kind of a low Joan Rivers and she has a rather curvaceous body with alabaster skin. With a very feminine face on a slender neck, she looked quite stunning in a long gown and high heels because she is at least 5'10" tall. Bebe is a terrible singer but she has great stage presence. She is an old pro at pleasing a crowd and she knows how to silence hecklers with snappy one-liners. She introduced the other ladies: Deseri, Frankie, Frenchy and Coco.

Deseri did the first number. She is a tall gorgeous black girl and she came on in a long bronze ruffled gown to sing and dance "Fame". Too bad she couldn't sing as well as she looked. She also got tangled in the miles of cables and disconnected her amplification several times but kept going. She then sang a slow ballad and







everyone wished her amplification was disconnected again, but no such luck.

Then Frankie came on. Frankie (the last name escapes me) is a 40-50 year old seasoned pro who must have been clicking around in high heels on the stage for the last 20 years. She seemed well known here. She sang "The man in the moon is a drag queen" while her white gown sparkled. Bebe then came on and the two of them sang "Bosom Buddies" while engaging in some funny feminine back biting: Bebe to Frankie: "Remember how we all wanted to look like Elizabeth Taylor? Well, now she does!" Frankie to Bebe: "Your dress looks like a nice table cloth.-.. covering a table."

Next was Frenchy, a short (about 5'5") beautiful little Latin lady who could make some great dance moves. Her costume was a knockout - a red sequined dress with a red feather hem and matching red high heels and, of course, a red feather boa. She did a disco number and sang a song.

Then Coco came on. Coco is a fortyish black lady who looks and sings like Pearl Bailey. She was fantastic and brought the house down. Bebe ended the first half with a strip tease. Now, I'm no authority on such things, but I thought she was excellent. While the band blared out the appropriate music, she started out in a long blue gown and gloves and ended with coinsiderably less. She used two huge blue feather boas and part of the stage curtain to deliver the 'coup de grace'.

During intermission I got a chance to see who was in the audience. A surprising number of well-dressed young women were there — either with girl friends or boy friends. There were also a good number of cross dressers there — I saw at least ten or more, dressed up for the occasion. The crowd was very frisky that night — they all seemed to be really into impersonators.

The second half started out with all the girls on the stage in very sexy costumes. Bebe wore a skin-tight leather dress and Deseri had on a

showgirl outfit: black leotard with a silver sequined jacket and high heels. They all sang "Big Spender" together and then Deseri did a dance solo to a feverish drum beat. She looked much better than her first number and I gave her a big hand. Frankie then came on again and started to sing "I'm just one of the gals who's just one of the boys" but she forgot the words and ended up just throwing out one-liners. But the crowd was with her and she wore a ravishing gown with a red sequin flame design so it wasn't a total loss.

Next was something unusual - a male exotic dancer. Now, I'm not into male dancers; I came to see the ladies. But I can tell you - this guy was awesome. His stage name was Stiletto and he must have studied gymnastics for years. He did back flips and gyrations that defied gravity - a class act to put it mildly.


Let's see - what was next? I think Bebe sang a bawdy song, Frenchy did two more songs, Coco gave another show-stopping performance singing "Bridge over troubled water" in a beautiful lavender gown and then all the girls wound up the show singing the old Fats Waller standard, "This joint is jumpin". It was quite a show.

A funny thing happened to me while I was watching the ladies. I got to wishing I could be up there on stage, dressed in some gorgeous outfit and singing and dancing like Liza Minelli. Fortunately this is only a

temporary affliction and I'm sure it will go away as soon as I buy a red sequined dress like Frenchy's. I wonder what kind of life people like Bebe live. Could you imagine making a living as a female impersonator? I'm sure there are stranger and harder ways to earn a livelihood, but I can't think of one at the moment. For any of you who are interested in the subject, I can suggest a fine little book. "Mother Camp" by Esther Newton. In the book she writes about a number of impersonators who worked in the Kansas City, Chicago and New York areas in the late sixties. She reveals that most impersonators don't lead glamorous lives like Jim Bailey and Danny LaRue. Instead they must often endure performing in seedy dives with performance fees that would'nt pay for half a tube of lipstick. If they look like glamorous women it might help their careers, but that isn't all it takes. They may have to sing or dance or both, be a stand-up comic and please all types of crowds - straight, gay, young or old. Bebe and her entourage of she-males were a mixed bag of uneven talent, but they put on quite a show - sleazy and sophisticated, silly and exciting. If you ever get a chance to catch her act some day before she retires, you will probably have a good time.

Yes, the Mascaraed One is the face gracing the January-February issue of the mag—even though he's not an alum. His mug appears in connection with an article on androgyny.

Jagger's secret project: a dressy video series

MICK Jagger, the Rolling Stone who refuses to settle down and gather moss, is making a video serial to promote his long-awaited solo album — and it will tell the story of a rock star down on his luck.

"It's the reverse of rags to riches," said a source. "He's an aging rock star who's becoming a has-been. He was very successful and had lots of money and becomes a regular guy. I think at one point he winds up in jail."

Like the old Saturday afternoon serials with the cliffhanging, to-be-continued endings, the clips will lead into each other. Putting them all together, Mick, the star and director, will have a 55-minute feature.

The serial is a departure from the standard practice of making separate videos for each song. Mick apparently decided it would be more interesting to string them together into one plot.

He flew down to Brazil with Jerry Hall last week to shoot the series on a three-week schedule, sources said.

It is not known if the tentative title, She's the Boss, from one song on the album, is autobiographical or not.

The crew brought along a \$30,000 wardrobe of about 40 outfits designed by Andre Van Pier, the 26-year-old boy wonder of Seventh Avenue, who also supplies Julio Iglesias with cashmere suits at \$4000 per.

According to a spokesman for Van Pier, the costumes Mick will be wearing in the video include a \$3000 brocade and silver lame jacket, long johns, ski pants, knickers and a tuxedo.

"Mick, at least in one part of the video, will be seen in a red dress," said our source. "He was fitted for it in his apartment."

Model Jerry Hall — Mick's flame and mother of his baby daughter — will get to go before the camera in a white terry cloth robe with gold trimming.

A spokeswoman at Columbia Records said she couldn't confirm any of this because Mick doesn't even keep the company posted on the secret project. "He has full artistic control," she said.

The album — Mick's first solo effort in 20 years with the Stones — was produced by industry hotshots Nile Rodgers and Bill Laswell and features such rock legends as Peter Townshend of The Who, Jeff Beck and Herbie Hansack.

A duet with Michael Jackson, recorded at the same time as "State of Shock," on Jackson's Victory album, will also be included.

And on the cover? A photo of Mick himself -





The Other Side

I recently completed a study of 55 women who were in current relationships with transvestites and I want to tell you their story. My intent is to describe the woman's view of a relationship between a woman and a man who crossdresses.

The most striking insight that came from my study was how isolated and misunderstood such women are, Any male who crossdresses knows first-hand the anxiety and isolation that goes with this behavior, especially in the early years. There is always some concern about being discovered. Can you imagine why a male would want to wear women's clothing, for to her it is her normal clothing and usually has no special feeling associated with it. When you add to this confusion her concern that her partner's crossdressing might become public knowledge, she can be in a terrified state. She may also worry about being a lesbian and about her partner being gay. Because crossdressing (unfortunately), is not generally acceptable in this society, she may be afraid to confide in anyone because so far as she is concerned her partner's behavior reflects on her. What will people think of her if she tells them her partner likes to wear women's clothing?

Further, many counselors and therapists do not understand crossgender behaviors and so may be of little help to her or may switch their attention to her partner because he is 'more interesting'. In addition, there is little information available to her to help her understand his behavior or her own feelings. If she reads typical transvestite literature, she may think that the fantasies in them are real and that her partner wants to become a full time woman and leave her. Thus the social stigma attached to crossdressing coupled with a lack of information serves to isolate her.

These women and their partners were (from outside appearances), typical middle class couples. Only about half of the women and about half of the men had ever been in counseling for any reason. The women in my study were probably not typical of many women who have a crossdressing partner because most of them had some connection with an organization that supported crossdressing males.

The women said that their partner's crossdressing needs often put strains on the relationship but they stayed because they loved him and/or because their relationship has other aspects that were good — balancing out the negative aspects of the crossdressing. There appeared to be an undertone in some responses which indicated that it would be difficult for the woman to leave the relationship because she was economically and/or socially trapped.

Another finding that was significant (keeping in mind that the women in my study had chosen to stay in the relationship), was that the earlier in the relationship the male told her about his crossdressing, the more probable it was that she would be accepting (to some degree), of his behavior. Just when she was told (or should be told), was not clear. The women who were told about the crossdressing in the first year and definately before marriage or living together were ther most accepting or tolerant. Also, the more sensitive her partner was to her needs and concerns, the more likely it was that she would elect to stay in the relationship -- if she had a choice. Her acceptance or tolerance of the crossdressing should not be confused with enjoyment or encouragement. What it probably meant was that she had come to terms with the crossdressing, learning that it was an immutable part of her partner's personality. Her decision to stay may also imply that she had developed some skills with which to cope (ignore) the problems associated with the crossdressing. High on the list of support for partners of crossdressers were the other women she met through the wives groups that were associated with crossdressing organizations. Unfortunately, most of the women in my study did not find out about these other women until some time after the initial disclosure which meant they were isolated for some period of time -- perhaps years!

Now I have heard some crossdressers say that what their partner thinks or feels is immaterial so long as she totally accepts his crossdressing needs or gets out of the way so that he can be free to express himself. My belief is that ALL relationships have to be built on a mutual give and take arrangement if they are to survive in a meaningful way. What many of the women in my study said was that they were as supportive of their partner's needs as they knew how to be but he often did not consider her needs or feelings. The study results highlight areas of the woman's

There's no easy answer

Dear Ann Landers: Problem: Our 13-year-old son. As a small child he liked to dress in women's clothes. He loved my silk and satin garments and high-heeled shoes.

Last week I discovered he had cut up a pair of his old trousers and made himself a mini-skirt. I'm sure he has been wearing it when he is alone.

The boy does not look feminine. I see no signs of homosexuality. Will you check with your experts, and tell me: How did this behavior get started? Is it related to his environment or was it built-in at birth? What can be done, if anything, to put a stop to it? Would counseling or therapy help? Does this mean the boy is homosexual?

He had a loving home and good upbringing. I am sure we made mistakes, like all parents, but I know of no reason for him to turn out like this. Thanks for any help you can give us.

Dear Parents: I spoke with an expert, a psychiatrist at UCLA. He
pointed out the need for psychiatric
evaluation to determine what type of
cross-dressing is present. Some
cross-dressers want to be women.
Others cross-dress to experience erotic pleasure when they put on
women's clothes. Still others do it for
homosexual fun and games.

The causes of cross-dressing are multiple, complex and still not understood. There is no evidence in most cases that it is biological in origin. In the case of those who cross-dress for erotic excitement, many report that they were dressed like little girls as punishment when they were young.

You ask if this practice can be stopped. The expert I spoke to made it clear that it is very difficult to get a cross-dresser to alter his behavior,

even with intensive treatment.

He also stressed that cross-dressers are not usually homosexuals, nor do they present a danger to society.

Food For Thought

I'd like to share some feelings and beliefs I have concerning being ourselves and belief in God.

So few of the facts concerning us are known by psychiatrists and psychologists; that much less on the part of most clergy. Most people in the mental health field would probably characterize us as in need of therapy; I guess that most clergy would view us as candidates for damnation. Unfortunately, these opinions are usually arrived at by the experience of the clergy and the mental health professionals with the "fringe" TV element. These sisters can not cope with their feelings and desires, and due to good, old "society", can only exist (be accepted ?), by living as drag queens and others who are "off the wall". Some basis for forming clinical and theological judgements!

Several of you may not believe in God, and fine, your dressing does not cause you problems. Others may have chucked their religious beliefs and opted to pursue crossdressing and say, "live and let live". Some of you may be experiencing great difficulty in accommodating your femme selves, and still attempt to practice, with due diligence, your beliefs. This can cause you a lot of grief; I know, I've had it.

Many of us have described the self-acceptance of our femme selves as becoming a "whole person". That is very true. The war within is over. We can now devote attention to those outside ourselves. Our wives, family, good friends, etc. I don't mean that you toss all your male things and go around saying, "I'm me and I've accepted myself". Good, old "society" still makes the rules which we have to follow to put bread on the table. This is still, however, a most happy experience, even if your self-acceptance is











communicated to no other person than yourself, but much more so when you can share this "special joy" with your sisters.

Self-acceptance turns on a light in your mind. You become more interested in others than yourself. You become a more caring person. You look in the mirror in your favorite dress and feel good about what you see and about yourself. (Universally, mental health professionals say that a mark of good mental health is feeling good about yourself). You meet/write/phone your sisters and are concerned about them, and they you. You are happy!!!

You wonder, "why? Why am I like this?" You accept yourself and you realize that there is no answer to the question "why". We are part of the great spectrum of humanity. Now, recognizing this, and assuming that you do believe in God, you may reach the conclusion that you are another manifestation of His/Her existence. Not that Father this or Rabbi that would agree with you at first, but its true!

With what the self-acceptance of your femme self gives you, and recognizing that you are in some way part of God's Great Plan, you become a better person. You acknowledge that God has made you, for whatever His/Her reason, the way you are. Being a "believer", and having accepted yourself, you begin to see that you can be a better husband, father, friend, helper. You are no longer wrapped-up in yourself, and you are more willing to "go the extra mile" for a particular purpose. In short, you become a better human being, Good signs, I think, of love of God and psychological health.




