Cross-Port Basics

The Fun Fashions Night was a big success in terms of turn out. 18 people came to see the items available. We welcomed Alice and Rabecca for the first time. A BIG THANKS for everyone that made it. The business was kept short inorder to get the show on the road, so I'll bring up some of the information later under Girl Talk.

One Stop Bra and Swim Shop has extended their offer to possibly opening one night a month for us, but I have had very little feed back from any of you as to whether you wish to do this kind of thing, so for now I'll have to put it on hold. I won't ask them to open the shop for 1 or 2 people.

The meeting broke up about 10: 30 and people headed down to the Subway. A special thanks to Bonnita and Zoe for their time and presentation.



Last time I talked about some of the bad things about the law and cross-dressing, this time I'm going to address the Pro's of cross-dressing but before I do I wanted to say a couple more things about going out in public.

If you are walking on the street and a police officer spots you as a cross-dresser. They can inquire into the reason for your being dressed that way and request proper I. D. But if there are no other problems they can't arrest you in Ohio just for being cross-dressed.

If you should become involved in a scene with someone not so open to your dressing even if you are in the right, the chances are that you will be arrested. You will also have a hard time obtaining witnesses as they will not want to get involved with a cross-fresser. The best thing you can do is LEAVE QUIETLY. Get away before the police arrive.

Well now that I've popped your bubble, you've sold your car and hide in the closet to dress let me tell you the good news. As I've already said you can't be arrested just for cross-dressing, so before you go out make sure all your lights and turn signals are working and have your proper I. D. Use common sense when driving and don't draw attention to yourself.

There have been two court cases and according to the outcome of both, it would appear that we do have a legal right to cross-dress in Ohio.

In 1975 Supreme Court of Ohio: Columbus Ohio vs Rogers, 41 Ohio St. 2D161324NE20563. It said a municipal ordinance prohibiting cross-dressing was un constitutional.

In 1974 Lower Appeals Court of Cincinnati Ohio, Cincinnati Ohio vs Adams, 42 Ohio Misc 48 330N32463. It said the same thing.

Write these down and keep them with you. If an officer should threaten to arrest you, advise him/her in a POLITE way of the 2 court cases and state that since he/she as been informed of the two cases if you are arrested he/she could become liable in a false arrest suit. Explain that you are aware of others feelings and attitudes toward your dressing but that the courts have up held your right to do so. (Edtors Note:) A resent case in St. Louis met the fate in court as being to vauge. According to their law a woman dressed in jeans and a tee shirt would have had to prove that they were "Made for Women" or she could have been arrested.

Dr. Baum and Dr. Wicker are planning to attend the April meeting for observation and questions. They hope to make a more formal presentation at a future meeting.

We have a couple of cassette tapes in the library available for your use. The Male Transvestite, and The Way of the Transexual parts 1 & 2. I have listened to the first one and recommend it for those unsure of what they are and for wives who know about your dressing but want more information.

One of the things you asked for the most in the letters I receive from you is help with make-up. Well, help is on the way. We currently have four people interested in coming to a meeting to teach you about make-up. Some of them would cost us and some of them would not, so one of the major things we will be discussing at the April meeting is what kind of presentation do YOU want. One of the people (named Ann) is coming to the April meeting just to meet us and see if she can taylor her demonstration to our needs. She will answer some basic questions but she will not be doing make-overs or doing a demonstration at this meeting.

I do feel I must make a comment about the show at the last meeting. I am very proud of all of you for the large turn out. I feel we all had a good time and saw some interesting things, however, I feel many of you may have been somewhat disappointed. I know I was. I had talked at length with the people involved and I felt they understood what kinds of things we wanted to see and the sizes needed. In the end I think she was just a little unprepaired for us. She presented her standard show and it was good but it was not the types of things we were looking to buy. This is why I want us to discuss the make-up demo before we commit to someone.

Several of us are planning to attend the Spring Fling (May 1 - 4). A reminder that if you plan to attend you must have your money in by April 27, 1986. I have included price information for both the Spring Fling and Be All You Want To Be Weekend (June 5 - 8).

<u>A word to our Gay Friends.</u> - Lesbian/Gay Pride week is May 31 to June 8, 1986. We have been invited to be a part of the activities. If you feel you don't pass well or don't care if you pass please wear something to try to pass as best as you can until you get inside. (Like a jacket & sunglasses etc.) You don't have to live with my neighbors, I do.
