

Transformations. By the time Friday evening arrived, the anticipation and excitement overcame the fear, although I did chicken out a little bit and wore slacks instead of a skirt. Judy was sitting in the open air coffee shop right in the middle of the lobby, and she had no trouble picking us out. Wonder what gave us away.

At the meeting we met Sharon from Minneapolis. Dana would be flying in Saturday morning. Here we learned what was going to be expected of us. Tri-Ess sponsored an information and resource booth at the conference and our job was to build the booth, keep it stocked with Tri-Ess materials, hand out the materials and talk to as many people as we could about cross-dressing and cross-dressers. The conference was being attended by social workers, educators, government agencies, medical professionals, ministers and clergy, counselors, authors and scholars. It was a great opportunity to positively expose a large number of people to the experience of interacting with a cross-dresser and to show them that we are real people and that each of us is a part of a family experience. Terri, especially got a lot of attention as the wife of a cross-dresser. She did great!



The Correct Fragrance

With so many perfumes on the market, it can be challenging to pick the right one for you. To bring some order to this plethora of choices, I will describe how the fragrance industry classifies them.

The main categories of perfume are floral, oriental, chypre, fougere, citrus and green. These are best described by:

- Floral: These fragrances consist of natural blossoms usually rose and jasmine.
- Oriental: These fragrances consist of sweet balms and resins from Arabia and India.
- Chypre: These fragrances are characterized by the contrast of fresh citrus accord and oakmoss. The name Chypre coomes from the island of Cyprus.
- Fougere: These fragrances are based on the interplay between lavender, oakmoss and coumarin. This category has only men's fragrances and therefore is of little interest to cross dressers.
- Citrus: These fragrances consist of fruity scentsations.
- Green: These fragrances are characterized scents of the outdoors such as grass and leaves.

Three of these categories are further divided in sub categories which I will map out below.

Most categories or sub categories are further divided into fresh, crisp, classic and rich segments. These are defined as follows:

- Fresh: The lightest and brightest fragrances.
- Crisp: Light but more sharp interpretations of the fragrances.
- Classic: The more beautiful and traditional fragrances in the family.
- Rich: The deepest and richest fragrances.

So putting all of this together the fragrance map looks like this (with examples):

FLORAL – By far the largest category

Floral – #1 sub category in all of fragrance land

Crisp - Armani,, Charlie, Gio, Perry Ellis

Classic – Channel #22, Joy, L'air Du Temps, White Shoulders

Rich – Bill Blass, Cassini, Chloe, Estee, Paris, Wings, Aldehyde

Fresh – Anne Klein, Calvin Klein, Channel #19, Safari, Wrappings

Crisp – Gucci #1, Nina, White Diamonds, White Linen

Classic – Channel #5


