# **IFGE Board Members Attend HBIGDA Biennial Symposium**

The 17th Biennial Symposium of the Harry Benjamin International Gender Dysphoria Association was held October 31 to November 4, 2001 at the San Luis Resort, Galveston TX. Galveston is the place that Harry Benjamin selected to start the HBIGDA on May 19, 1981. This symposium is held every two years at venues all over the world.

IFGE was well represented at this symposium by Board members Kristine James, Alison Laing, Hawk River-Stone, Dianne Ellaborn, and Jamison Green. Presenters included Rikki Swin and Marcos from RSI, Jason Cromwell, Sandra Samons, Phyllis Frye , Rosalyne Blumenstein and Barbara Warren of GIP in NYC, Jill Weiss, who will be one of speakers at our convention in 2002, Dr. Meltzer and staff, Drs. Schrang and Biber, Sheila Kirk, Ann Lawrence, Randi Ettner and more. We found many of our friends and members in the audience as well.

There were thirteen major symposiums and plenary sessions and, one early morning concurrent Workshop which covered 5 different subjects. Each symposium contained four separate papers authored by respected leaders in the community from all over the world. There were over 200 attendees from the USA, Canada and over 15 foreign countries.

HBIGDA provided IFGE with a table near the registration desk for three days, to pass out information and answer a lot of questions concerning what IFGE is all about and how the professional community can participate in our programs. We passed out many copies of Transgender Tapestry and signed up one new member under our Professional Membership Program. The primary objective of the IFGE Executive Committee, was to bring to the professional community, IFGE, its mission and purpose, and how it can work with care-givers to provide better service to our community. We believe that we have started to accomplish this goal.

HBIGDA is an organization whose members are the care givers, research and legal professionals that supply services and counseling to the transsexual community. The sixth version of The Standards of Care for Gender Identity Disorders, published in 2001 are currently in effect. These standards are recognized as the guide lines for all surgeons, mental health professionals, hormone therapy and post-op follow-up of MtF or FtM during their transition.

Most of the presentations made on Thursday, were made by community leaders. Jamison Green set the pace with his talk on "The Language of Gender Variance". Is there a difference between transgendered, transsexual (or transexual), bi-gendered, queer, cross-dresser, transvestite? What are you? We discussed the fact that you can ask 100 people in our community and you are going to get 100 different answers to the question and therein lies the problem. In a profession that likes to put "everything in a box" and treat the problem according to the rules that fit that box, it is very difficult. This theme was carried out by many of the speakers that followed.

This was a great event that gave me ex-

tended coverage and direct contact with a portion of our community which many times is misunderstood by many of us. The discussions that I had with many of these service-providers and health care people were insightful and far-ranging. Most of the sessions that I attended, were focused, sometimes too detailed or lengthy, often controversial, but interesting.

The hotel was a wonderful venue with the Gulf of Mexico right out my front window. I was able to get some time in the Jacuzzi and the pool where I had an interesting conversation with Jill Weiss and friends. Although smoking may be bad for your health, several times when I stepped out the ballroom door into the patio area, I had the opportunity to speak with people whose names I have heard, but had never met. It was a wonderful experience, but I am not sure if I can go to the next one in 2003 in Denmark.

Dermatologist Richard Sharp was found competent to stand trial and convicted of murder last November for the shooting death of his wife. Dr Sharpe had plead not guilty by reason of insanity, and his defense council spent a lot of time citing his crossdressing as evidence of his poor mental condition. His crossdressing was also the major focus of the media's attention. The trial was nationally televised live in its entirety on Court TV.

# TG's Protected in Massachusetts

The Massachusetts Commission Against Discrimination (MCAD) ruled in last October that transgender people are protected under current Massachusetts laws prohibiting discrimination on the basis of sex or disability. Denise Leclair of the International Foundation for Gender Education (IFGE) was asked by Court TV to discuss transgender issues in a live interview from the Lawrence District Court in Massachusetts on November 16 during the trial. At Denise's invitation, Jennifer Levi, staff attorney from the Gay and Lesbian Advocates and Defenders (GLAD), also participated in the discussion. Ms Leclair stressed that the defendants gen-

necticut also bar discrimination based on gender identity

The Commission did not actually decide on the case in question, but rather ruled that the case would have to be heard in lower court where it had previously been dismissed. It based its decision in part on the landmark 1989 US Supreme Court case, Price Waterhouse v. Hopkins. In that case, the Supreme Court had ruled that enforcing sex stereotypes is a form of sex discrimination. The MCAD also noted that although federal disability laws specifically excludes transexualism, the Massachusetts law does not have the same exclusion.

Attorney Jennifer Levi, of the Gay & Lesbian Advocates & Defenders, who defended the case said "there is no principled reason, legal or otherwise, to graft an exclusion onto non-discrimination laws for transgender people." der identity was no more releveant to his innocence or guilt than his religion and ethnicity are. Jennifer Levi also discussed the negative impact this portrayal has on transgendered people trying to live normal, productive lives. The interview concluded on a positive note, with one of the interviewers offering a personal story about a transgendered nurse who had helped her family.

# Winn-Dixie Protester Murdered

Terrianne Summers of was found dead on December 12, in the driveway of her Jacksonville, Florida home. She died from a single .22 caliber gunshot wound to the back of her head, and reportedly had not been robbed. Many people are calling for the murder to be investigated as a hate crime.

Ms Summers was one of the leading activists and organizers in the protest against the Winn-Dixie grocery chain. Activists have been protesting Winn-Dixie for the firing of Peter Oiler, a 20 year employee, for crossdressing off the job.

Terrianne Summers was a 22 year Navy veteran, and is survived by her spouse and two children.

## Vanessa Hemingway Dies at age 69

Dr. Vanessa Hemingway, daughter of renound author Ernest Hemingway, died on October 1, 2001 in the Miami-Dade Women's Detention Center from complications due to heart disease and high blood pressure. Hemingway, a former medical doctor and author, had been arrested for indecent exposure and resisting arrest without violence on September 25 in Key Biscayne Florida.

Ms Hemingway, who suffered from manic depression, was walking nude along the main thoroughfare in Key Biscayne carrying her mately reduce the number of adults that have little or no knowledge of transpersons.
